## RESOLUTION NO. 190

"WHEREAS, His Honor, the City Mayor, has to this august Body conveyed, through the City Legal Officer, his desire to transfer or cause to be transferred, immediately, the Sunday Market Fair from its present site on portions of Rizal and Lopez Jaena streets to the vacant lots behind the City Hall building for three main reasons, to wit:

- 1. The closure of the said portions of Rizal and Lopez Jaena streets on Sundays is offensive to the Land Transportation and Traffic Code;
- 2. The Fair, considering the numerous makeshift shanties, boxes and other containers on the streets plus the Fair-goers, is a potential hazard to lives and limbs aside from being a fire hazard; and
- 3. Indiscriminate littering of waste and other refuse has aggravated the city's garbage disposal problems.

"WHEREAS, it has also been the desire of this august Body to transfer the site of the Sunday Market Fair from its present location for which the Committee on Laws and Ordinances was authorized to conduct, and did conduct, a public hearing with the market stallholders and residents, as well as merchants and store operators of Rizal and Lopez Jaena streets who were agreeable to the transfer of the site somewhere else;

"WHEREAS, the City Administration has been contemplating to establish a new public market somewhere in the reclamation carea where the market fair (tabu) can be held permanently so that for the present, in view of the reasons manifested by the Honorable City Mayor, it has become imperative to temporarily transfer the market fair site to the area recommended by His Honor;

"NOW, THEREFORE, on motion of Councilor Samson, seconded jointly by Councilors Marquez and Porcadilla;

"RESOLVED, to adopt:

ORDINANCE NO. 13 AN ORDINANCE ESTABLISHING A SUNDAY MARKET FAIR (TABU) IN THE CITY OF ORMOC, DESIGNATING A TEMPORARY SITE THEREOF, REPEALING IN THIS CONNECTION ORDINANCE NO. 29, SERIES OF 1970, AND FOR OTHER PURPOSES

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Title. - This Ordinance shall be known as the "Sunday Market Fair Ordinance of Ormoc City".

SECTION 2. Sunday Market Fair: its temporary site. -There is hereby estabbished a market fair (tabu) every Sunday of the week in the City of Ormoc to he held at the vacant lots behind the City Hall building temporarily until such time when a permanent site shall be designated.

SECTION 3. Repeal. - Ordinance No. 29, series of 1970, and all other ordinances relative to the establishment of a special market day in the City of Ormoc inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. Effectivity. - This Ordinance shall take effect immediately on Sunday, December 2, 1973.

ENACTED, November 29, 1973.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Treasurer, the Market Administrator, the Chief of Police, the City Engineer, the City Health Officer, merchants and traders concerned, and the general public, all in the City of Ormoc;
