"RESOLVED, to adopt:

ORDINANCE NO. 7

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 5, CURRENT
SERIES, OTHERWISE KNOWN AS THE "1973-1974 ORMOC CITY
BUDGET", SO AS TO PROVIDE FOUR (4) INSTEAD OF ONLY
THREE (3) LABORERS IN ITEM NO. 5 OF (C-25a) AGRICUL-
TURAL AND VETERINARY EXTENSION SERVICES, APPROPRIATING
FUND FOR ADDITIONAL COMPENSATION THEREOF.

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Section 2 of Ordinance No. 5, current series,
otherwise known as the "1973-1974 Ormoc City Budget", is here-
by amended so as to provide four (4) instead of only three (3)
Laborers in Item No. 5 of (C-25a) Agricultural and Veterinary
Extension Services.

SECTION 2. For purposes of this Ordinance, the sum of
three thousand pesos (P3,000.00), or so much thereof as may
be necessary, is hereby appropriated out of funds existing
in the City Treasury not otherwise appropriated, said sum to
be made available for supplemental appropriation for compen-
sation of one (1) additional Laborer under (C-25a) Agricultu-
ral and Veterinary Extension Services: Provided, that fund
for the same shall be provided in subsequent general appro-
priations.

SECTION 3. This Ordinance shall take effect as of July
1, 1973.
