ORDINANCE NO. 8

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 59,
SERIES OF 1970, WITH REFERENCE TO SUGAR CENTRALS

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Item A-101 under Factories and Manufacturers
of Section 2, Ordinance No. 59, series of 1970, with reference
to sugar centrals, is hereby amended to read as follows:

"A-101 - Sugar centrals: (to be paid before the start of
every crop year on the basis of previous actual
production)
a) with production of 1,000,000
piculs up P20,000.00
b) with production of 500,000
piculs up but less than
1,000,000 piculs P10,000.00
c) with production of less
than 500,000 piculs P 5,000.00"

SECTION 2. This Ordinance shall take effect immediately
upon its approval.
