"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE AMENDING SECTION 1 OF ARTICLES 10  
AND 11, RESPECTIVELY, UNDER CHAPTER II OF  
ORDINANCE NO. 14, SERIES OF 1973, OTHERWISE  
KNOWN AS THE ORMOC CITY TAX CODE OF 1973

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Section 1 of Article 10, under Chapter II  
of Ordinance No. 14, series of 1973, otherwise known as  
the Ormoc City Tax Code of 1973, is hereby amended by add-  
ing a new sub-section thereof to be known as sub-section  
"j" and to read as follows:

"(j) Other clearances:

1. Certificate of clearance  
of good conduct (City Mayor) ..... P1.00
2. Certificate of clearance  
of a person (City Fiscal) ..... 1.00
3. Certificate of clearance of  
sanitation of business estab-  
lishment (City Health Officer) ... 2.00
4. Certificate of clearance of physical  
fitness (City Health Officer) ..... 2.00
5. Certificate of tax clearance  
(City Treasurer) ..... 1.00
6. Certificate of clearance of non-  
encumbrance of real property  
(City Assessor) ..... 1.00
7. Certificate of clearance of fire safety  
(Chief, Fire Department), P0.10 per point  
but not less than P1.00 for the first  
clearance for the building: Provided that  
for subsequent clearance for the same  
building, the fee shall be 25% of the  
original fee.



SECTION 2. Section 1 of Article 11, under Chapter II of Ordinance No. 14, series of 1973, otherwise known as the Ormoc City Tax Code of 1973, is hereby amended by adding two new items to sub-section "f" thereof to be known as items "8" and "9" and to read as follows:

- "8. For registration of birth  
of a child ..... ₱1.00  
9. For issuance of birth  
certificate of a person ..... 1.00"


SECTION 3. Effectivity. - This Ordinance shall take effect as of January 1, 1974.






