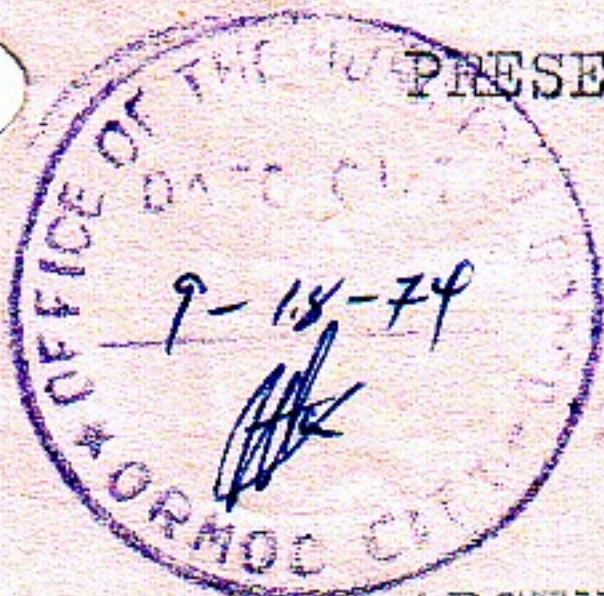
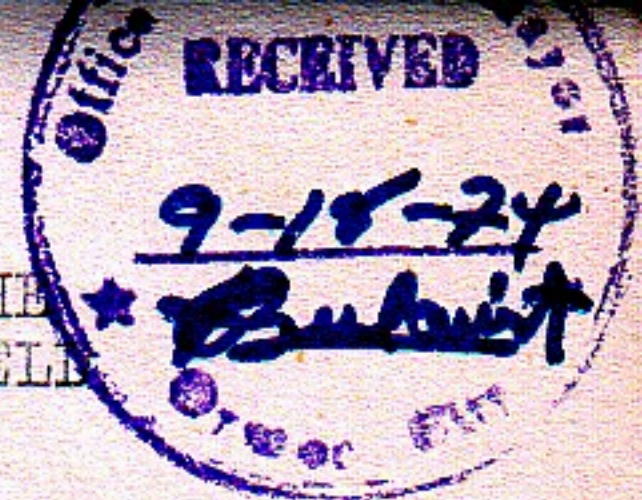

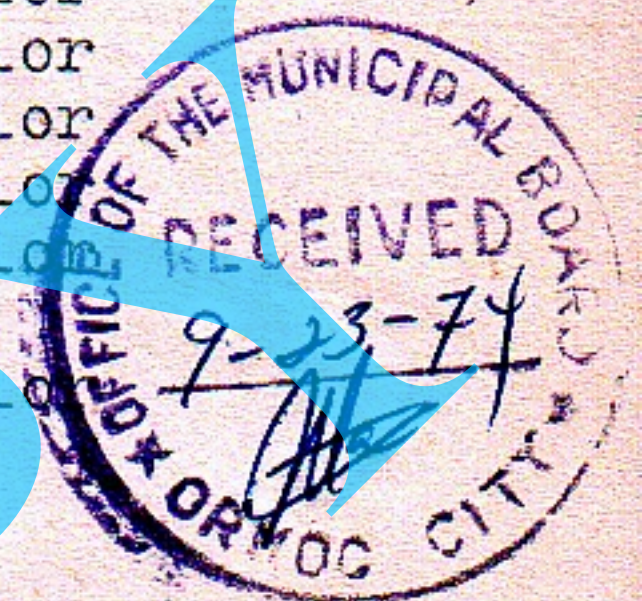

RESOLUTION NO. 133

"WHEREAS, the Office of the City Judge has been asking for an appropriation for outstanding obligation on the salary difference of the Judge covering the period from December 1, 1972, to June 30, 1974, inclusive, amounting to P2,850.00 as previously requested for incorporation in the current city budget but neither the City Auditor nor the City Treasurer knows if the same will be paid by the national or the city government;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Mendola;

"RESOLVED, to adopt:

ORDINANCE NO. 15

AN ORDINANCE TO AMEND ORDINANCE NO. 9, CURRENT SERIES, MORE PARTICULARLY KNOWN AS THE "1974-1975 ORMOC CITY BUDGET"

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Amendment. - Section 2 of Ordinance No. 9, current series, more particularly known as the "1974-1975 Ormoc City Budget" is hereby amended by incorporating an item for Outstanding Obligation under (C-11) CITY COURT to read as follows:

"3. Outstanding Obligation

"9 : Salary difference of Judge Josephine K. Bayona from P1,000.00 to P1,150.00 a month for the period from December 1, 1972, to June 30, 1974, inclusive P2,850.00"

SECTION 2. Appropriation; disbursement. - For purposes of this Ordinance the sum of two thousand eight hundred fifty pesos (P2,850.00), or so much thereof as may be necessary, is hereby appropriated out of funds existing in the city treasury not otherwise appropriated: Provided, however, That disbursement of the same shall be subject to auditing rules and regulations.

SECTION 3. Effectivity. - This Ordinance shall take effect upon approval by the City Mayor.






