RESOLUTION NO. 135

"WHEREAS, the Waterworks Superintendent in his letter of September 13, 1974, has requested the restoration of the positions of one Clerk-Collector and one Bill Collector as these items were honestly overlooked in the enactment of the current city budget and requested, further, that the item for travel and transportation be also restored in his office the same as those of other offices;

"WHEREAS, the City Treasurer in his letter dated September 23, 1974, has also requested the amendment of the recapitulation of the Street and Bridge Fund in the current city budget so as to charge part of the expenditure for materials against the 'C' fund instead of the 'J' fund as a whole as originally proposed, otherwise, the estimated expenditure in the Street and Bridge Fund will exceed the estimated revenue thereof by P285,808.00;

"WHEREAS, in a conference with the Waterworks Superintendent and the Committee on Finance of this august Body the former chose the restoration of even the position of the Clerk-Collector at P3,240.00 per annum as appearing in the previous city budget as Item No. 11 in his office and that the amount of P500.00 will be sufficient for travel and transportation of the same office;

"NOW, THEREFORE, on motion of the Floor Leader, seconded jointly by Councilors Porcadilla, Marquez and Tan;

"RESOLVED, to adopt:

ORDINANCE NO. 16

AN ORDINANCE AMENDING FURTHER ORDINANCE NO. 9,  
CURRENT SERIES, OTHERWISE KNOWN AS THE  
"1974-1975 ORMOC CITY BUDGET"

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Amendment to Recapitulation of Street and Bridge Fund. - Item "E" on Materials of the Street and Bridge Fund Recapitulation under the Engineering and City Public Services, as found in Section 2 on page 21 of Ordinance No. 9, current series, otherwise known as the "1974-1975 Ormoc City Budget", is hereby split into two as "E-1. Materials: J-27(5) at P171,468.31" and "E-1. Materials: C at P285,808.00" so that the whole Recapitulation will now read as follows:



"RECAPITULATION (D to H):

"D. Maintenance of City Roads, Streets  
and Bridges: J-27(5) ..... P141,695.03  
E. Materials: J-27(5) ..... 171,468.31  
E-1. Materials: C ..... 285,808.00  
F. Rental of Equipment: J-27(5)j ..... 200,000.00  
G. Fuels, Oils, Spare Parts, etc.: J-25(5)a. 138,182.96  
H. Overhead: J-26-5(k) ..... 94,792.70  
GRAND TOTAL, D to I ..... P1,031,952.00"

SECTION 2. Amendment to (C-35) Waterworks System. -  
(C-35) Waterworks System under Section 2 of Ordinance No. 9,  
current series, otherwise known as the "1974-1975 Ormoc City  
Budget", is hereby amended by inserting the following items  
on page 22 thereof:

a) Under "1. Salaries and Wages" add a new item to be known  
as Item No. 10-A which shall read as follows:

"10-A : Clerk-Collector ..... 1 P3,240.00"

b) Under "2. Contingent Expenses" add a new item to be known  
as Item No. 31 which shall read as follows:

"31 : Travel and Transportation ..... P 500.00"

For this purpose, the sum of three thousand seven hun-  
dred forty pesos (P3,740.00), or so much thereof as may be  
necessary, is hereby reverted from out of Item No. 26 on the  
purchase of watershed area of the Waterworks System: Provid-  
ed, however, That funds therefor shall be provided in subse-  
quent general appropriation ordinances.

SECTION 3. Effectivity. - This Ordinance shall take ef-  
fect as of July 1, 1974.

ENACTED, September 26, 1974.

tor, the City Engineer, and the Waterworks Superintendent,  
all of Ormoc City;
