"RESOLVED, to adopt:

## ORDINANCE NO. 2

AN ORDINANCE AMENDING, FURTHER, ORDINANCE NO. 14, SERIES OF 1973, OTHERWISE KNOWN AS THE ORMOC CITY TAX CODE OF 1973

BE IT ORDAINED, by the Municipal Board of Ormoc City. That:

SECTION 1. Section 1 of Article 10, under Chapter II of Ordinance No. 14, series of 1973, otherwise known as the Ormoc City Tax Code of 1973, as amended by Ordinance No. 1, current series, is hereby amended, further, by adding a new item to sub-section "j" thereof to be known as Item No. 8 and to read as follows:

"8. Certificate of clearance of sanitary and hygienic facilities and nonexistence of epidemic or communicable diseases in connection with barrio fiesta and the like celebration .. (City Health Officer) ...... ₱5.00 (Ord. No. 9, series of 1950)"

SECTION 2. Ordinance No. 14, series of 1973, otherwise known as the Ormoc City Tax Code of 1973, as amended, is hereby amended, durther, by adding a new article to Chapter II thereof to be known as Article 21 and to read as follows:

## "ARTICLE 21. IMPOSITION OF CITY TAX FOR A CERTAIN NUMBER OF BOARD FEET OF LUMBER SOLD AT ORMOC CITY

"SECTION 1. City tax. - There shall be paid to the City Treasurer a city tax of five pesos (\$5.00) for every one thousand (1,000) board feet of lumber sold at Ormoc City by any person, partnership, firm, association, corporation or entity.

"SECTION 2. Time and manner of payment and penalty for delinquency. - The city tax herein imposed shall be payable without penalty within twenty (20) days after the close of every quarter for which the tax is due. Failure to pay the tax within the prescribed time shall render the taxpayer subject to a surcharge of fifty percent (50%) for the first offense and one hundred percent (100%) for subsequent failures to pay within the prescribed period.

"SECTION 3. Payment to be rendered by taxpayer. - The taxpayer is hereby obliged to include the tax submitted for payment to the City Treasurer within twenty (20) days after the close of every quarter.

(Ord. No. 13, series of 1964)"

SECTION 2. Effectivity. - This Ordinance shall take effect as of January 1. 1974.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Secretary of Finance, Manila; the Honorable Secretary of Local Government and Community Development, Quezon City; all department or office heads of the City Government, the Judge of the Court of First Instance, the Commanding Officer, 352nd PC Co., Camp Downes, and the general public by posting copies of this Ordinance at the bulletin boards of the City Hall, the Post Office, the Public Market, and all other public buildings in the City of Ormoc;
