RESOLUTION NO. 15

"WHEREAS, the Waterworks Superintendent in a communication dated January 30, 1974, has requested an additional appropriation of two hundred pesos (P200.00) to the item on building rental in view of the termination of the contract of lease of the building they are occupying on February 28, 1974, after which the new contract will carry an increase of fifty pesos (P50.00) per month beginning March 1, 1974;

"WHEREAS, the Waterworks Superintendent also requested the amendment of Item No. 20 under contingent expenses of his office by adding the words 'and bicycle' to the phrase 'Repair of waterworks equipment' without any change in the original amount of appropriation therefor;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Mejia;

"RESOLVED, to approve the requests of the Waterworks Superintendent and do, as this Body hereby does, adopt:

ORDINANCE NO. 3

AN ORDINANCE AMENDING ITEMS NOS. 20 AND 22 OF THE  
WATERWORKS SYSTEM UNDER SECTION 2 OF ORDINANCE  
NO. 5, SERIES OF 1973, OTHERWISE KNOWN AS THE  
1973-1974 ORMOC CITY BUDGET

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Item No. 20 of (C-35) Waterworks System under Section 2 of Ordinance No. 5, series of 1973, more particularly known as the 1973-1974 Ormoc City Budget, is hereby amended by adding the words "and bicycle" only so that said item will read as follows:

"20 : Repair of waterworks equipment  
and bicycle ..... P1,500.00"

SECTION 2. Item No. 22 of (C-35) Waterworks System under Section 2 of Ordinance No. 5, series of 1973, more particularly known as the 1973-1974 Ormoc City Budget, is hereby amended by adding P200.00 thereof so that said item will read as follows:



"22 : Building rental (from ₱1,200.00) ..... ₱1,400.00"

For purposes of this section, the sum of two hundred pesos (₱200.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of (C-35) Waterworks System, said sum to be made available for supplemental appropriation to this particular item.


SECTION 3. This Ordinance will take effect on March 1, 1974.



"CARRIED UNANIMOUSLY."




