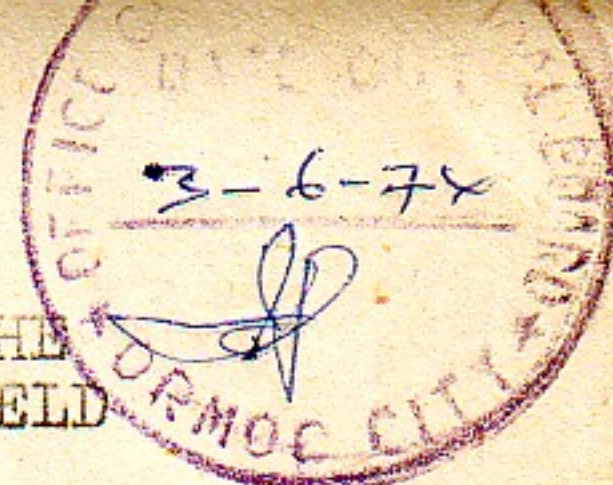

RESOLUTION NO. 25

"WHEREAS, our Senior Clerk-Stenographer, who has been wooed by the Court of First Instance to apply for the vacant position of Court Stenographer which carries an item with a very much higher rate of compensation than what he is receiving now, manifested that he will forgo the application if we raise his salary a little bit more by even twenty-five pesos per month inasmuch as he is the only city employee who got the least increase while the greatest bulk of the employees got each a minimum raise of fifty pesos per month, not to mention a few holders of very indispensable positions who got each a raise of seventy pesos per month;

"WHEREAS, in fairness to our Senior Clerk-Stenographer who is now in his twenty-first year in the office of the Municipal Board rendering service in his usual efficient, diligent and conscientious ways, faithful to his avowed duties and responsibilities as a humble civil servant, this august Body finds it fitting and proper to readjust his compensation by granting him the same minimum rate of increase as those of the greatest majority of the city employees considering also that the indispensability of the position cannot be gainsaid;

"NOW, THEREFORE, on motion of Councilor Mendola, seconded jointly by Councilors Marquez, Porcadilla and Mejia;

"RESOLVED, to adopt:

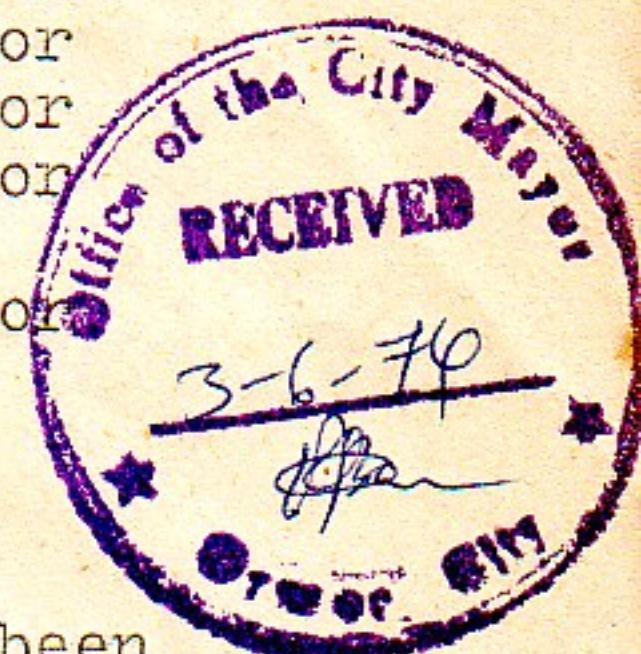
ORDINANCE NO. 4

AN ORDINANCE AMENDING ITEM NO. 4 OF (C-2) MUNICIPAL BOARD UNDER SECTION 2 OF ORDINANCE NO. 5, SERIES OF 1973, OTHERWISE KNOWN AS THE 1973-1974 ORMOC CITY BUDGET, PROVIDING FUNDS FOR THE RATE DIFFERENCE THEREFOR, AND FOR OTHER PURPOSES

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Amendment. - Item No. 4 of (C-2) Municipal Board under Section 2 of Ordinance No. 5, series of 1973, otherwise known as the 1973-1974 Ormoc City Budget, is hereby amended so as to read as follows:

"4 : Senior Clerk-Stenographer
(from ₱5,700.00) ₱6,300.00"



SECTION 2. Appropriation. - For purposes of this Ordinance, the sum of three hundred pesos (P300.00), or so much thereof as may be necessary, is hereby reverted from out of salary savings of the Municipal Board, said sum to be made available for supplemental appropriation to the salary difference of the Senior Clerk-Stenographer of the same department: Provided, however, that funds for this purpose shall be provided for in subsequent general appropriation ordinances.


SECTION 3. Effectivity. - This Ordinance shall take effect as of the First Day of July, Nineteen Hundred and Seventy-Three.


"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Treasurer and the City Auditor, both of Ormoc City;

"CARRIED UNANIMOUSLY."




