RESOLUTION NO. 44

"WHEREAS, His Excellency, President Ferdinand E. Marcos, on February 17, 1974, issued Presidential Decree No. 390 granting emergency cost of living allowance at the rate of fifty pesos (P50.00) a month per employee and laborer of the Government, who are actually receiving a salary below P600.00 per month, in order to alleviate the plight of the low income group by providing them with the means to cushion the impact of increased prices and cost of living as a consequence of the worldwide inflation primarily brought about by the energy crisis;

"WHEREAS, in consonance with Presidential Decree No. 390, the Honorable City Vice-Mayor and Presiding Officer of the Board immediately organized a special committee of four under his chairmanship with the Chairman of the Committee on Finance, the City Treasurer, and the City Auditor as members, to immediately undertake a thorough study on the present finances of the city and to find ways and means to implement the Presidential Decree in the City of Ormoc;

"WHEREAS, after a lengthy deliberation of the special committee, the Honorable City Vice-Mayor and Presiding Officer of the Board came up with a report that the City Treasurer is certifying to the availability of the sum of eighty thousand pesos (P80,000.00) to cover the emergency cost of living allowances of all city employees, laborers and high school teachers for the period from March to June, 1974;

"NOW, THEREFORE, on motion of the Vice-Mayor and Presiding Officer, seconded unanimously by the Floor Leader and Councilors Mendola, Marquez, Porcadilla, Samson and Mejia;

ORDINANCE NO. 6

AN ORDINANCE APPROPRIATING THE SUM OF EIGHTY THOUSAND PESOS (P80,000.00) OUT OF THE OVERCOLLECTIONS OF CITY LICENSES AND REAL PROPERTY TAXES FOR THE CURRENT FISCAL YEAR TO BE MADE AVAILABLE AS SUPPLEMENTAL APPROPRIATION FOR EMERGENCY COST OF LIVING ALLOWANCES OF ALL CITY EMPLOYEES, LABORERS AND HIGH SCHOOL TEACHERS IN CONSONANCE WITH PRESIDENTIAL DECREE NO. 390 DATED FEBRUARY 17, 1974

BE IT ORDAINED, by the Municipal Board of Ormoc City,  
That:

SECTION 1. Supplemental budget. - The sum of eighty thousand pesos (P80,000.00), or so much thereof as may be necessary, is hereby appropriated out of the overcollections of city licenses and real property taxes for the current fiscal year, said sum to be made available as supplemental appropriation for emergency cost of living allowances of all city employees, laborers and high school teachers in consonance with Presidential Decree No. 390 dated February 17, 1974: Provided, however, that funds for this purpose shall be provided in subsequent general appropriation ordinances.

SECTION 2: Effectivity. - This Ordinance shall take effect as of the First Day of March, Nineteen Hundred and Seventy-Four, A.D.

ENACTED, March 21, 1974.

"RESOLVED, FURTHER, to furnish a copy of this resolution ordinance each to the City Treasurer, the City Auditor, and all other heads of departments and/or offices of the Government of Ormoc City;
