## RESOLUTION NO. 101

"WHEREAS, during the revision of the 1974-1975 Ormoc City Budget following the directive of the Department of Finance the position of Bill Clerk in the Waterworks System was inadvertently abolished instead of the position of Clerk-Collector created under Resolution No. 135-Ordinance No. 16, series of 1974, which was replaced by the position of Laborer in the revised budget;

"WHEREAS, in view of such inadvertence the incumbent Bill Clerk of the Waterworks System might be disallowed to collect her salary which, as a matter of fact, had already been adjusted, among others, with an increase of ten per- / cent pursuant to Presidential Decree No. 593 effective January 9, 1975, as per our Resolution No. 2-Ordinance No. 1, current series;

"WHEREAS, it behooves this august Body to rectify the error by restoring the position of Bill Clerk in the Waterworks System in fairness to the incumbent who has been in the service since January, 1965, and abolishing the position of Clerk-Collector thereof, repealing for this purpose Section 2 of Ordinance No. 16, series of 1974;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by Councilor Mendola;

"RESOLVED, to adopt:

ORDINANCE NO. 17

AN ORDINANCE TO RESTORE THE POSITION OF BILL CLERK IN THE WATERWORKS SYSTEM WITH COMPENSATION AT THE RATE OF THREE THOUSAND FIVE HUNDRED SIXTY-FOUR PESOS (#3,564.00) PER ANNUM, AS PER ORDINANCE NO. 1, SERIES OF 1975, AND ABOLISHING THE POSI-TION OF CLERK-COLLECTOR IN THE SAME OFFICE

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Restoration of the position of Bill Clerk in the Waterworks System. - The position of Bill Clerk in the Waterworks System, which had been inadvertently abolished in the revision of the 1974-1975 Ormoc City Budget, is hereby restored with the same rate of compensation at Three Thousand Five Hundred Sixty-Four Pesos (\$3,564.00) per annum, as per Ordinance No. 1, series of 1975.



SECTION 2. Abolition of the position of Clerk-Collector in the Waterworks System; repeal of Section 2 of Ordinance No. 16, series of 1974. - The position of Clerk-Collector in the Waterworks System is hereby abolished, repealing for this purpose Section 2 of Ordinance No. 16, series of 1974.

SECTION 3. Effectivity. - This Ordinance shall take effect immediately upon its approval.
