RESOLUTION NO. 103

"WHEREAS, the late Honorable Rodolfo Mijares Rivilla, an officially adopted son of Ormoc City, legislator, phialanthropist, industrialist, farmer and a gentleman, has spent the best years of his life in the service of his country in general, and of the Fourth District of Leyte which he ably represented in Congress in particular;

"WHEREAS, Rudy Rivilla, as he was fondly known to his associates (Nonoy Rudy to his countless friends and admirers), has left behind a resplendent record of service both in the public and private sectors, most prominently in the fields of industry, agriculture and politics, scaling the ranks from a humble salesman of the Tru Ade Corporation in his early youth, then Resident Manager of the Ormoc Sugar Company, Inc., General Manager, Ormoc Broadcasting Company, Chairman, Board of Industries of the Philippines, Assistant General Manager, Ormoc Sugar Company, Inc., Congressman for the Fourth District of Leyte, and then as the Vice-President of the Hilongos Development Corporation;

"WHEREAS, Rudy Rivilla has well and faithfully served his constituents in the Fourth District of Leyte as a dedicated public servant advocating fair play and uprightness in all his dealings with his fellowmen either in business or politics, thus winning to his side the hearts of even his former political adversaries;

to the proposition that giving is more blessed than receiving, hence his unselfish devotion to the public good, his ever-readiness in lending a helping hand to charitable, religious and civic organizations, and in ministering to the needy;

"WHEREAS, Rudy Rivilla has contributed in no small way to the prosperity of Ormoc City where he spent many years as resident manager of the Ormoc Sugar Company, Inc., and where he established the Ormoc Broadcasting Company which are now distinguished landmarks of the city's economic progress;

"WHEREAS, it is but proper and desirable in commemoration of his name that one of the city's thoroughfares be renamed after him;

"NOW, THEREFORE, on motion of the Vice-Mayor and Presiding Officer, seconded unanimously by Councilors Mendola, Marquez, Porcadilla, Samson and Mejia;

"RESOLVED, to adopt:

ORDINANCE NO. 18

AN ORDINANCE TO RENAME HARRISON STREET IN BARRIO
CAN-ADIENG LEADING TO BARRIO IPIL IN THE
CITY OF ORMOC "RUDY RIVILLA AVENUE"

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Renaming of Harrison Street. - Harrison Street in Barrio Can-adieng leading to Barrio Ipil in the City of Ormoc is hereby renamed "Rudy Rivilla Avenue".

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, July 24, 1975.

"RESOLVED, FURTHER, to direct the Office of the City Engineer to prepare and immediately post the proper street name signs in conspicuous places for purposes of this resolution-ordinance; and

Rivilla, all of Carlos Rivilla Building, Makati, Rizal; the City Engineer, the City Postmaster and all other heads of departments and/or offices, the residents of Harrison Street (now Rudy Rivilla Avenue), and the general public, all of Ormoc City;
