ORDINANCE NO. 19

AN ORDINANCE TO AMEND SECTION 2 ON MAYOR'S PERMIT FEES,
UNDER CHAPTER II, ARTICLE 19, OF ORDINANCE NO. 1
(ORD. NO. 14, S. 1973, AS AMENDED), OTHERWISE
KNOWN AS THE ORMOC CITY TAX CODE OF 1973.

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Amendments. - Section 2 on Mayor's permit
fees, under Chapter II, Article 19, of Ordinance No. 1
(formerly designated as Ordinance No. 14, series of 1973,
as amended), otherwise known as the Ormoc City Tax Code
of 1973, more particularly, Item No. 19 of SHOPS AND MA-
CHINERIES and, also, OTHER ITEMS, is hereby amended, to
wit:
