RESOLUTION NO. 12

"WHEREAS, the Honorable City Judge has requested the adjustment of her salary (city share) in pursuance of Presidential Decree No. 516, from P8,760.00 to P18,250.00 per annum, to take effect as of July 1, 1974, as per Supreme Court Administrative Order No. 163, series of 1974, so that there is a need to amend the item of the City Judge under Section 2 of Ordinance No. 9, series of 1974, otherwise known as the '1974-1975 Ormoc City Budget', in accordance with the above-mentioned statutes, which would result in the following computation:

Salary per annum (city share, per PD 516 and SC Administrative Order No. 163) effective July 1, 1974)	P18,250.00
Actual salary per annum (city share, per Ord. No. 9, series of 1974)	8,760.00
Salary difference per annum	P9,490.00
Salary difference per month: (P9,490 ÷ 12) ..	P 790.83
Salary difference for 6½ months (from July 1, 1974, to Jan. 15, 1975)	P5,140.40

"WHEREAS, by virtue of Presidential Decree No. 503 granting 10% across-the-board salary increases there is, also, a need to adjust the salary of the City Judge from P18,250.00 to P20,075.00 per annum (city share) effective January 16, 1975, in accordance with Ordinance No. 1 dated January 9, 1975;

"NOW, THEREFORE, on motion of Councilor Porcadilla, seconded jointly by Councilors Mendola and Mejia;

"RESOLVED, to adopt:

ORDINANCE NO. 2

AN ORDINANCE AMENDING THE ITEM OF THE CITY JUDGE FROM P8,760.00 PER ANNUM (CITY SHARE) PER ORDINANCE NO. 1, SERIES OF 1975, TO P18,250.00 PER ANNUM PURSUANT TO PRESIDENTIAL DECREE NO. 516 AND SUPREME COURT ADMINISTRATIVE ORDER NO. 163, SERIES OF 1974, EFFECTIVE JULY 1, 1974, AND TO ADJUST THE SAME TO P20,075.00 PER ANNUM (CITY SHARE) PURSUANT TO PRESIDENTIAL DECREE NO. 503, EFFECTIVE JANUARY 16, 1975, PROVIDING FUNDS FOR SALARY DIFFERENCES OF SAID POSITION, AND FOR OTHER PURPOSES

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. City Judge's salary adjustment per Presidential Decree No. 516 and Supreme Court Administrative Order No. 163, series of 1974. - The city share for the salary of the City Judge at ₱8,760.00 per annum, per Ordinance No. 9, series of 1974, otherwise known as the 1974-1975 Ormoc City Budget, is hereby adjusted to ₱18,250.00 per annum pursuant to Presidential Decree No. 516, effective July 1, 1974, in line with Supreme Court Administrative Order No. 163, series of 1974.

SECTION 2. City Judge's salary adjustment per Presidential Decree No. 503. - The city share for the salary of the City Judge at ₱18,250.00 per annum, per Presidential Decree No. 516 and Supreme Court Administrative Order No. 163, series of 1974, is hereby adjusted to ₱20,075.00 per annum pursuant to Presidential Decree No. 503, effective January 16, 1975, in accordance with Ordinance No. 1, series of 1975.

SECTION 3. Appropriation. - For purposes of this Ordinance the following sums, or so much thereof as may be necessary, are hereby reverted from out of the continuing appropriations to the unexpended balance of the general fund, to be made available for supplemental appropriation in the manner and purposes provided hereunder, to wit:
