"RESOLVED, to adopt:

ORDINANCE NO. 20

AN ORDINANCE TO AMEND ARTICLE 1 OF ORDINANCE NO. 2,
SERIES OF 1950, OTHERWISE KNOWN AS THE
BUILDING ORDINANCE OF ORMOC CITY.

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Amendment. - Article 1 of Ordinance No. 2,
series of 1950, otherwise known as the Building Ordinance
of Ormoc City, is hereby amended to read as follows:

"ARTICLE 1. PERMIT

"Before any person, firm, corporation or
entity starts to construct, repair, modify or
alter any structure or building in the City of
Ormoc, the owner or his authorized representa-
tive shall apply and secure from the office of
the City Engineer a permit for same and be duly
approved by the City Mayor. After having secur-
ed the necessary permit it shall be the duty of
the owner or the contractor to place a placard
or signboard in a conspicuous place of the cons-
truction or repair site indicating the building
permit number, official receipt number, date of
issue, and other pertinent information. The
construction, repair, modification or alteration
of any structure or building prior to securing
the necessary permit shall be considered illegal
and, therefore, such structure is subject to de-
molition and removal if the City Engineer deems
necessary."

SECTION 2. Effectivity. - This Ordinance shall take
effect immediately upon its approval.

ENACTED, September 25, 1975.


"RESOLVED, FURTHER, to furnish a copy of this Ordinance each to the City Engineer, the City Treasurer and all other heads of departments and/or offices, all building contractors, and the general public, in the City of Ormoc;




