ORDINANCE NO. 21

AN ORDINANCE TO AMEND ITEM NO. 15 OF SECTION 7
UNDER ARTICLE 12 OF CHAPTER II OF ORDINANCE
NO. 1 (ORD. NO. 14, S. 1973) AS AMENDED),
OTHERWISE KNOWN AS THE ORMOC CITY
TAX CODE OF 1973

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Amendment. - Item No. 25 on Boxing contests of Section 7 under Article 12 of Chapter II of Ordinance No. 1 (formerly designated as Ordinance No. 14, series of 1973, as amended), otherwise known as the Ormoc City Tax Code of 1973, is hereby amended pursuant to paragraph (g), Section 19 of Presidential Decree No. 231, as amended by Presidential Decree No. 426, and shall read as follows:

"SECTION 7. Tax on amusement places. - x x x

x x x x .

"15. Boxing contests, ₱100.00 each night, plus an amusement tax of ₱0.05 per admission ticket payable on the day following the contests. The admission tickets should be registered with the City Treasurer's office before being used."

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, October 16, 1975.

"RESOLVED, FURTHER, to furnish a copy of this Ordinance each to the City Treasurer, the City Auditor, stadium owners, boxing promoters, and the general public, in Ormoc City;
