RESOLUTION NO. 145

"WHEREAS, the public market complex construction will pretty soon start so that the Sunday Market Fair (tabu) now occupying the construction site will have to be transferred to another site;

"WHEREAS, after weeks of deliberate study coupled with investigations and ocular inspections for a most probable site to temporarily transfer the Sunday Market Fair, this august Body has decided to designate the old police department site and its vicinity in the Government Center it being the safest place for a market fair;

"NOW, THEREFORE, on motion of Councilor Samson, seconded by the Floor Leader;

"RESOLVED, to adopt:

ORDINANCE NO. 22

AN ORDINANCE TO TRANSFER THE MARKET FAIR FROM ITS PRESENT SITE TEMPORARILY TO THE OLD POLICE DEPARTMENT SITE AND ITS VICINITY IN THE GOVERNMENT CENTER, AMENDING FOR THIS PURPOSE ORDINANCE NO. 13, SERIES OF 1973.

BE IT ORDAINED, by the Municipal Board of Ormoc City, That:

SECTION 1. Transfer of market fair. - The Sunday Market Fair (Tabu) is hereby temporarily transferred from its present site at the reclamation area to the old police department site and its vicinity in the Government Center, amending for this purpose Ordinance No. 13, series of 1973.

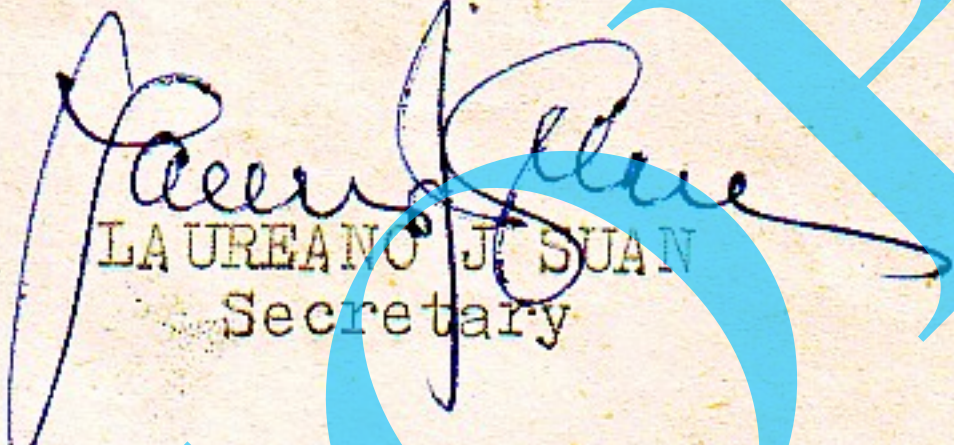
SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, November 13, 1975.

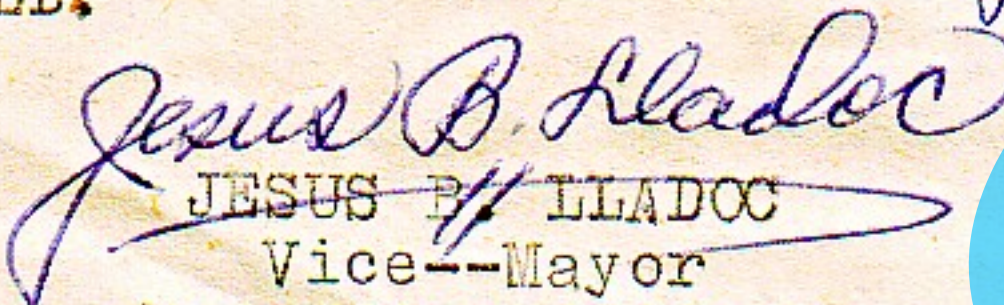

"CARRIED UNANIMOUSLY."

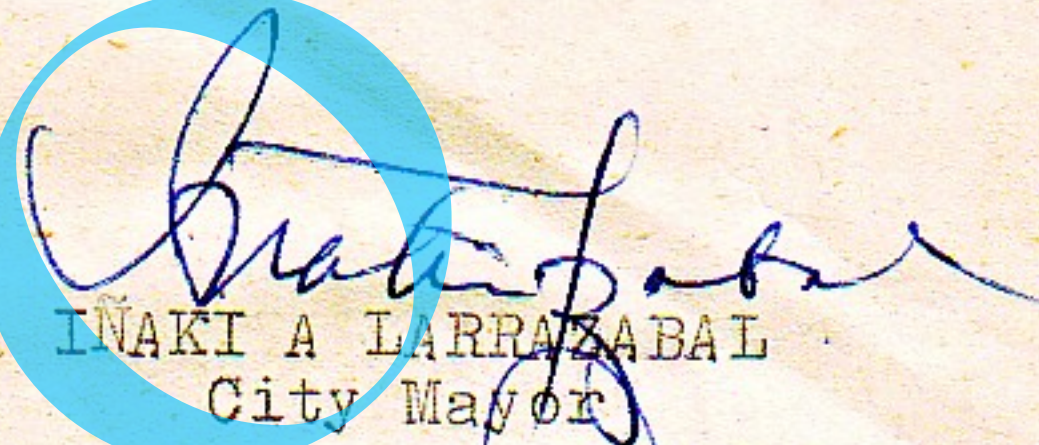

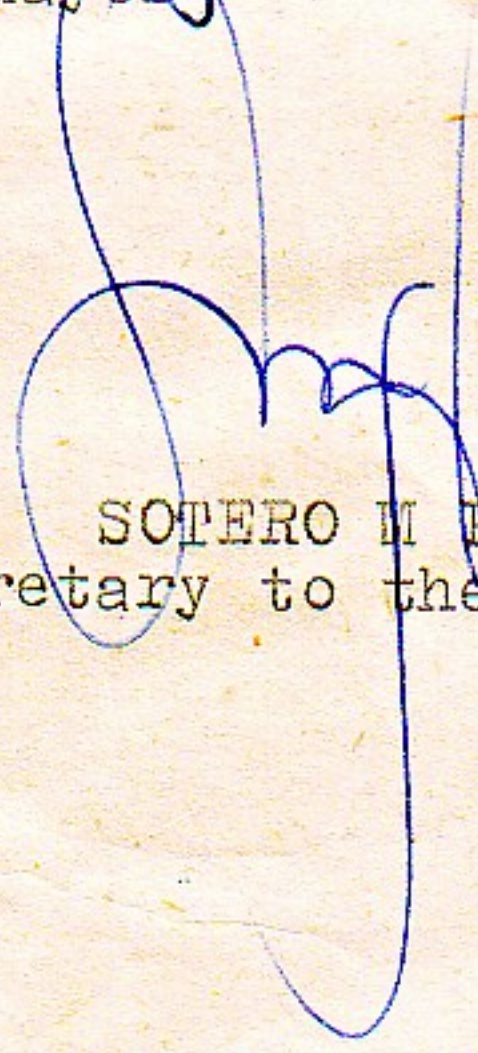
