ORDINANCE NO. 3

AN ORDINANCE TO AMEND SECTION 3 OF ORDINANCE
NO. 2, CURRENT SERIES

BE IT ORDAINED, by the Municipal Board of Ormoc City,
That:

SECTION 1. Amendment. - Section 3 of Ordinance No. 2,
current series, is hereby amended to read as follows:

"SECTION 3. Appropriation. - For purposes of
this Ordinance, the sum of nine thousand four hun-
dred ninety pesos (P9,490.00), or so much thereof
as may be necessary, is hereby reverted from out-
of the continuing appropriations to the unexpend-
ed balance of the general fund, said sum to be
made available for supplemental appropriation for
the salary difference of the City Judge to cover
the period from July 1, 1974, to June 30, 1975:
Provided, however, That funds for this purpose
shall be provided in subsequent general appropri-
ations ordinance."

SECTION 2. Effectivity. - This Ordinance shall take
effect as of July 1, 1974.
