RESOLUTION NO. 159

"The City Sangguniang Bayan, on motion of Kagawad Marquez,
unanimously seconded;

"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE AMENDING CHAPTER II OF ORDINANCE NO. 10, SERIES
OF 1969, OF THE MUNICIPAL BOARD, OTHERWISE KNOWN AS THE
"MARKET AND SLAUGHTERHOUSE CODE OF ORMOC CITY".

BE IT ORDAINED, by the Sangguniang Bayan of Ormoc City, That:

SECTION 1. Amendments. - In consonance with Sections 35 and
36 of Presidential Decree No. 856, otherwise known as the CODE
OF SANITATION OF THE PHILIPPINES, promulgated December 23, 1975,
Chapter II of Ordinance No. 10, series of 1969, of the Municipal
Board, otherwise known as the MARKET AND SLAUGHTERHOUSE CODE OF
ORMOC CITY, is hereby modified by amending Section 5-A thereof
and adding a new section thereunder to be known as Section 5-B
which shall read as follows:

"SECTION 5-A. Sanitary maintenance and inspection;
Responsibility of the City Health Officer. - The sani-
tary maintenance and inspection of markets and slaugh-
terhouses shall be under the direct supervision and
control of the City Health Officer who shall be res-
ponsible:

a) On markets - to:

1. Make periodic inspections to ascertain the
maintenance of adequate sanitary conditions
of markets and their premises;

2. Supervise and control the proper care and use of market stalls;
3. Prohibit the construction of living quarters within any market and its premises;
4. Enforce the ban on construction of partitions, sheds or booths within the market area.

(Sec. 35-a, PD 856)

b) On abattoirs - To:

1. Supervise the maintenance of adequate sanitation in abattoirs and their premises;
2. Enforce the requirements on the examination of meat as provided in existing laws;
3. Permit the slaughter of animals for public consumption in other designated areas in certain exigencies, provided public health is adequately protected;
4. Supervise the sanitary disposal of all abattoir wastes; and
5. Ensure that only health animals shall be slaughtered, and that the method of slaughtering, the techniques of dressing and storing, handling and transporting procedures are in accordance with prescribed standards.

"SECTION 5-B. Responsibility of the city and and the market operators. - The City Government and the private operators in charge of public or private markets and abattoirs shall employ an adequate number of personnel to ensure their efficient operation and hygienic maintenance. These employees shall be under the direct supervision of the City Health Officer. (Sec. 36, PD 856)

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, September 14, 1976.

"RESOLVED, FURTHER, to furnish a copy of this Ordinance each to His Honor, the City Mayor, the City Health Officer, the Market Administrator, the City Treasurer, all other department/office heads, market stallholders, and the general public, all of Ormoc City;
