RESOLUTION NO. 255

"WHEREAS, it has become imperative to create the position of one (1) Laborer in the Office of the City Sangguniang Bayan, as a matter of fact such laborer has already been working and assigned to the Sangguniang Bayan Secretariat ever since last December, 1976, after the 1977 City Budget had already been approved by this august Body;

"NOW, THEREFORE, on motion of Kagawad Cristobal S. Mendola, unanimously seconded;

"RESOLVED, to adopt:

ORDINANCE NO. 4

AN ORDINANCE CREATING THE POSITION OF ONE (1) LABORER IN THE OFFICE OF THE CITY SANGGUNIANG BAYAN WITH COMPENSATION AT THE RATE OF THREE THOUSAND THREE HUNDRED PESOS PER ANNUM, PROVIDING FUND THEREFOR, AND FOR OTHER PURPOSES, EFFECTIVE JANUARY 1, 1977

BE IT ENACTED, by the Sangguniang Bayan of Ormoc City, That:

SECTION 1. Creation of the position of Laborer, Sangguniang Bayan. - The position of one (1) Laborer in the Office of the Sangguniang Bayan, Ormoc City, is hereby created with compensation at the rate of three thousand three hundred pesos (P3,300.00) per annum, said amount of compensation or so much thereof as may be necessary to be reverted from out of the salary savings of this same office: PROVIDED, however, That funds for this purpose shall be provided in subsequent general appropriation ordinance.

SECTION 2. Effectivity. - This Ordinance shall take effect as of January 1, 1977, subject, however, to the approval of the Regional Director, Department of Local Government and Community Development, as an exemption to
