RESOLUTION NO. 268

"WHEREAS, the Deputy Chief and Officer In-Charge of the Ormoc City Fire Station in his communication of even date has requested the change of the designation of the positions of the Driver-Mechanic, Assistant Driver-Mechanic, and Drivers to Fire Truck Operators, and that of the Electrician-Lineman to Fireman Electrician, inasmuch as the former positions partake of a civilian employee each to report only during regular office hours and, as such, are not considered regular members of the INP Fire Services, according to the recommendation of higher INP authorities;

"WHEREAS, this august Body finds the request of the Deputy Fire Chief to be most worthy of consideration taking into account the indispensability of drivers and electricians in the fire department day in and day out so much so that they ought to be regular members of the INP Fire Services as in reality they form part and parcel of the fire fighting force; ever since their first day of service;

"NOW, THEREFORE, on motion of Kagawad Cristobal S. Mendola, unanimously seconded;

"RESOLVED, to adopt:

ORDINANCE NO. 5

AN ORDINANCE TO CHANGE THE DESIGNATION OF CERTAIN POSITIONS IN THE ORMOC CITY FIRE STATION TO QUALIFY THEM FOR REGULAR MEMBERSHIP THEREOF AND FOR OTHER PURPOSES

BE IT ORDAINED, by the Sangguniang Bayan of Ormoc City,  
That:



SECTION 1. Change of designation of certain positions in the Ormoc City Fire Station. - The designation of the positions ~~in~~ the Ormoc City Fire Station of Driver-Mechanic, Assistant Driver-Mechanic, and Drivers, are hereby changed to "Fire Truck Operators" and that of the Electrician-Line-man to "Fireman Electrician" to qualify them for regular membership thereof.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
