"RESOLVED, to adopt:

ORDINANCE NO. 7

AN ORDINANCE AMENDING ORDINANCE NO. 4, SECTION 1,
IN PARTICULAR

BE IT ENACTED, by the Sangguniang Bayan of Ormoc City,
That:

SECTION 1. Amendment. - Section 1 of Ordinance No. 4 dated January 11, 1977, otherwise known as An Ordinance Creating the Position of One (1) Laborer in the Office of the City Sangguniang Bayan with compensation at the rate of Three Thousand Three Hundred Pesos Per Annum, Providing Fund Therefor, and for Other Purposes, Effective January 1, 1977, is hereby amended to read as follows:

"SECTION 1. Creation of the position of Laborer, Sangguniang Bayan. - The position of one (1) Laborer in the Office of the Sangguniang Bayan, Ormoc City, is hereby created with compensation at the rate of three thousand three hundred pesos (P3,300.00) per annum, said amount of compensation or so much thereof as may be necessary to be appropriated by way of reversion of fund from out of the salary savings of the vacant position of Filing Clerk of the same office: PROVIDED, however, That funds for this purpose shall be provided in subsequent general appropriation ordinance.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.


