RESOLUTION NO. 323

"WHEREAS, by virtue of the authority vested in him by Resolution No. 272 of the City Sangguniang Bayan, the Honorable City Mayor has entered into a sub-agreement with the Population Commission under which sub-agreement it becomes necessary to create the City Population Office under the Office of the City Mayor for the integration of population-related programs, activities and services at the city and barangay levels;

"NOW, THEREFORE, on motion of Kagawad Besabella, unanimously seconded;

"RESOLVED, to adopt:

ORDINANCE NO. 8

AN ORDINANCE CREATING THE CITY POPULATION OFFICE
UNDER THE OFFICE OF THE CITY MAYOR

BE IT ENACTED, by the Sangguniang Bayan of Ormoc City,
That:

SECTION 1. The City Population Office; its functions.

- The City Population Office is hereby created under the Office of the City Mayor which shall have the following functions:

(a) To coordinate all population and family planning services and activities of all agencies in the City who are engaged in such services;

(b) To coordinate the distribution of family planning supplies and the establishment of Barangay Supply Points throughout the City;

(c) To encourage all Married Couples of Reproductive Age (MCRA) to adopt the safest and most effective methods of family planning and to prevent unwanted conception by these persons who wish to space, limit or prevent pregnancies;

(d) To coordinate the provisions of family planning services through the participating agencies responsible for the delivery of these services; and

(e) To conduct educational and informational drives to achieve the aims and purposes of the National Population Program.

SECTION 2. Agency assistance. - In order to carry out the purpose and objectives of this Ordinance, all agencies involved in population and/or family planning activities in the City of Ormoc shall be required to assist in the Population/Family Planning efforts of the City.

SECTION 3. Appropriation. - For purposes of this Ordinance there shall be incorporated in the City General Fund Annual Budget sufficient appropriation for the operation and maintenance of the City Population Office for the outreach project in accordance with the cost absorption plan agreed upon by and between the Population Commission and the City of Ormoc as spelled out by the Sub-Agreement entered into by and between the POPCOM and the City.

SECTION 4. Separability. - If any section or parts of this Ordinance shall be declared ultra vires or null and void by any competent court, the said declaration shall not in any way invalidate the whole of this Ordinance.

SECTION 5. Repeal. - Any ordinance or sections thereof inconsistent with this Ordinance are hereby repealed and/or modified accordingly.

SECTION 6. Effectivity. - This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Honorable Secretary of Finance, Metro Manila; the Regional Director, DLGCD, and the Regional Population Officer, both in Tacloban City; the Honorable City Mayor, the City Population Officer, and all other department/office heads, in the City of Ormoc;
