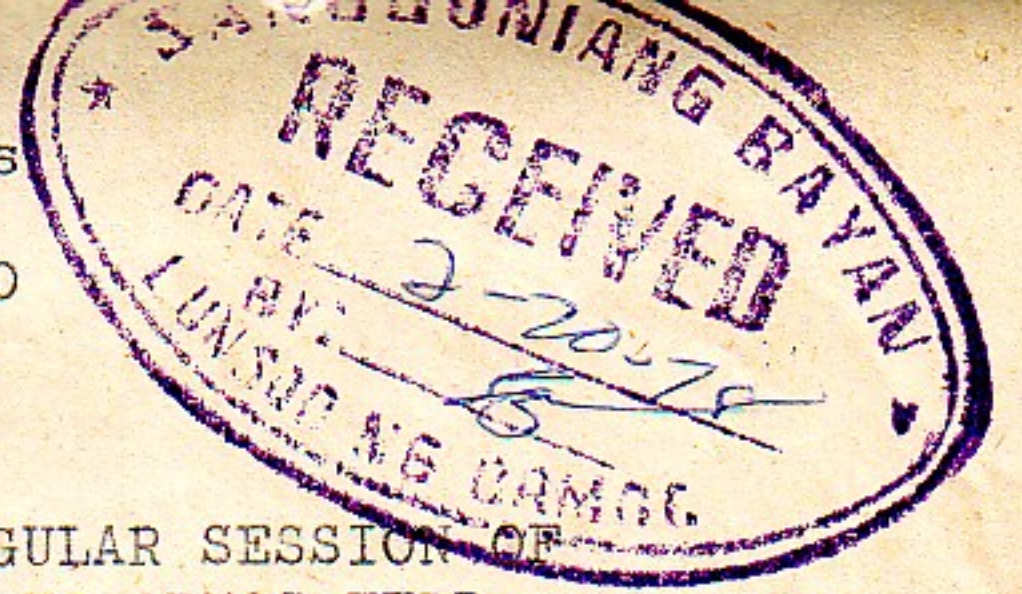

seconded by Kagawad Torrevillas;

RESOLVED, to adopt:

ORDINANCE NO. 15

AN ORDINANCE PRESCRIBING RULES, GUIDELINES AND REGULATIONS IN
THE DISTRIBUTION, DISPOSITION AND AWARD OF MARKET STALLS
TO PROSPECTIVE STALL HOLDERS OR OCCUPANTS IN THE CITY
PUBLIC MARKET COMPLEX.

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc,
That:

SEC. 1. Rules and Regulations.--Supplementing the provisions
of the City Revenue Code of 1977, in the distributions, disposi-
tion, and award of market stalls and/or premises to prospective
stall holders and/or occupants in the City Public Market Complex,
the market committee shall observed and be guided by the following
rules and regulations, viz:

a) Stall holders in the burned public market shall have
preference over all other applicants for stalls in the City
Market Complex. Only after all the old stall holders have
occupied or awarded stalls, or otherwise, have forfeited,
lost interest, or otherwise, desisted from occupancy of his

or her stall, shall the new applicant or applicants be given the chance, or allowed to participate in the drawing of lots for himself or herself to occupy a stall in the market complex;

b) No person shall be allowed and be awarded to occupy more than one stall;

c) The right to occupy a particular stall shall be determined by drawing of lots in order to avoid any corruptions and/or favoritism in the awarding of best located stalls;

d) Dummies should not be allowed and/or countenanced;

e) Stall holders are prohibited from selling, mortgaging and/or leasing to any other person, his or her right to occupy a market stall. Any stall holder who stops, retires, becomes bankrupt, or is unable to continue his or her business for any other reasons, shall be required to surrender the stall to the City Government through the City Treasurer, for proper disposition.

SEC. 2. Penalty.— Any person or stall holder who is found to be a dummy of another, or is found to have sold, mortgaged, or leased his or her stall or premises shall immediately be made to forfeit his or her right in favor of another to occupy the stall, and further, be disqualified to hold or occupy any market stall in the future or to participate in subsequent drawing of lots for construction or awarding of any vacant stall or stalls.

SEC. 3. Effectivity.— This ordinance shall take effect immediately upon its approval.

ENACTED, February 7, 1978.

RESOLVED, FURTHER, to furnish a copy of this Ordinance each to His Honor, the City Mayor, the City Treasurer, the Market Administrator, and the General Public, all in Ormoc City.

CARRIED. Thirteen (13) affirmative votes; one abstention registered by Kagawad Lladoc.
