RESOLUTION NO. 534

The Chair informed the Body that the Honorable City Mayor recommended to replace the vacant position of clerk-typist and to hire one who has taken up a course or study related to agriculture or at least a high school graduate as agricultural aide, instead of an "agronomist" to assist the City Agriculturist/Veterinarian in the Agricultural & Veterinary Extension Services with the same rate of compensation for the clerk-typist.

"RESOLVED, to adopt:

ORDINANCE NO. 17

AN ORDINANCE TO CHANGE THE DESIGNATION OF THE POSITION OF CLERK-TYPIST TO AGRICULTURAL AIDE IN THE AGRICULTURAL & VETERINARY EXTENSION SERVICES WITH THE SAME RATE OF COMPENSATION.

BE IT ENACTED, by the Sangguniang Panglungsod ng Ormoc,
That:

SECTION 1. Change of designation.— The designation of the position of "clerk-typist" in the Agricultural & Veterinary Extension Services is hereby changed to "agricultural aide" with the same rate of compensation, amending in this

connection Section 2 of Appropriation Ordinance No. 78-1,
otherwise known as the 1978 Ormoc City General Fund Budget.


SECTION 2. Effectivity.— This Ordinance shall take effect
immediately upon its approval.




