ORDINANCE NO. 18

AN ORDINANCE TO REGULATE PARKING IN ORMOC CITY AND PROVIDING PENALTY FOR VIOLATION THEREOF.

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Title. This Ordinance shall be known as the Ormoc City Parking Ordinance of 1978.

SECTION 2. Parking Regulations. Except as otherwise provided for in the succeeding section, it shall be unlawful to park any vehicle in any portion or portions in all other eity roads, thoroughfares, and national roads, within the perimeter of the poblacion of Ormoc City, between the hours of 12:00 midnight and 4:00 A.M. of the following day.

SECTION 3. Definition of Terms. For purposes of this Ordinance, the following terms are hereby defined:

1. Vehicles - refer, generally, to automotive vehicles,

and the like, especially those equipped with rubber or pneumatic tires for use on highways, roads, streets, and/or thoroughfares. These include cars, jeeps or jeepneys, motorcycles, motorcabs or motorized tricycles, motorbikes, trucks, buses, tractors, and so forth. However, for the purpose of this ordinance, vehicles also refer to animal-drawn carriages, like carreteles or rigs (tartanillas or paradas), carromatas and so forth.

2. Parking shall be understood to mean the leaving or stopping of the vehicle in any portion of the city street or national highway.

SECTION 4. Exemptions. The provisions of this Ordinance shall not, however, apply to fire trucks on actual fire fighting operation, police car on duty, ambulance fetching patients, and other vehicles attending to, or answering to emergency call or calls.

SECTION 5. On Vehicle Breakdown. Any breakdown of motor vehicles along city streets or roads covered by the provisions of this Ordinance shall likewise be subject to the provisions of Article 9, Chapter II, of the Ormoc City Revenue Code of 1977.

SECTION 6. Penalty. Any violation of the provisions of this Ordinance shall subject the offender to a fine of \$\overline{P}50.00 for first offense; and for any subsequent offenses, a fine of \$\overline{P}50.00 or imprisonment of not more than five (5) days, or both such fine and imprisonment at the discretion of the court.

SECTION 7. Repeal. Section 3 of Ordinance No. 16, series of 1969, is hereby amended, and any provisions of any other ordinance or ordinances which may be inconsistent herewith are hereby repealed or modified accordingly.

SECTION 8. Separability. If any section or portion of this Ordinance which might be declared unconstitutional or ultra-vires, the said declaration shall not invalidate the whole of this Ordinance.

SECTION 9. Effectivity .- This Ordinance shall take effect fifteen (15) days after its approval.
