RESOLUTION NO. 725

Presented for consideration is the request of the INP Station Commander, following the observation and recommendation of his Chief Traffic Officer, that the portion of Osmeña Street from Corner Real to Corner San Pablo Streets and the portion of Rizal Street from Corner Aviles to Osmeña Streets, which have been declared one-way-traffic streets, be restored to two-way traffic now for better convenience to motorists, not to mention time saved and energy conserved. It should be noted that the particular portion of Osmeña Street was opened for only one-way traffic when the north diversion road (now C. Hermosilla Drive) was still under construction, while the portion of Rizal Street was also declared a one-way-traffic street for the convenience and safety of market goers along this narrow street. Considering that the north diversion road is now practically absorbing the flow of all cargo trucks which used to run along Osmeña Street and, also, considering that the public market has already been transferred from Rizal Street to the reclaimed area in Sabang Beach, this august Body finds the request of the Station Commander well grounded;

To reckon with, the declaration of these particular portions of Osmeña and Rizal Streets as opened to only one-way traffic, among others, is covered by Municipal Board Ordinance No. 81 under Resolution No. 287 dated December 18, 1968. Another street is also opened to only one-way traffic - Aguadulce Street - from its corner on San Pablo Street up to Corner C. Aviles Street, which is not included in the request for restoration to two-way traffic;

There is, therefore, a necessity to repeal Ordinance No. 81, series of 1968, of the Sixth Municipal Board, while a new ordinance may be in order to maintain the one-way traffic on Aguadulce Street;



WHEREFORE, on motion of Kagawad Enecio, seconded jointly by Mga Kagawad Santiago and Mendola; be it

RESOLVED, to adopt:

ORDINANCE NO. 22  
AN ORDINANCE TO REPEAL MUNICIPAL BOARD ORDINANCE  
NO. 81, SERIES OF 1968

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Repeal of Municipal Board Ordinance No. 81, s. 1968. - Ordinance No. 81, series of 1968, of the Sixth Municipal Board of Ormoc City, is hereby REPEALED.

Section 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, October 2, 1979.

RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Station Commander and the Chief Traffic Officer, both of the Integrated National Police Station, and the City Engineer, all in Ormoc City;
