RESOLUTION NO. 725-A

With the repeal of Municipal Board Ordinance No. 81, series of 1968, there is a necessity to reenact a portion of said ordinance - the opening of Aguadulce Street to one-way traffic from its corner on San Pablo Street up to its opposite corner on C. Aviles street - as the restoration of this street to two-way traffic was not included in the recommendation of the Chief Traffic Officer of the Integrated National Police;

NOW, THEREFORE, on motion of Kagawad Enecio, seconded jointly by Mga Kagawad Santiago and Mendola; be it

RESOLVED, to adopt:

ORDINANCE NO. 23

AN ORDINANCE TO MAINTAIN THE ONE-WAY TRAFFIC OF AGUADULCE STREET FROM ITS CORNER ON SAN PABLO STREET TO ITS OPPOSITE CORNER ON C. AVILES STREET, PROVIDING PENALTY FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES.

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. One-way Aguadulce Street. - Aguadulce Street is hereby maintained as one-way traffic from its corner on San Pablo Street up to its opposite corner on C. Aviles Street.

SECTION 2. Penalty for violation. - Any violation of this Ordinance shall be punishable by a fine of twenty-five pesos or an imprisonment of not exceeding ten days, or both such fine and imprisonment at the discretion of the court.

SECTION 3. Repeal. - Any ordinance or provision thereof inconsistent herewith is hereby repealed or modified accordingly.


SECTION 4. Effectivity. - This Ordinance takes effect immediately upon its approval.

RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the City Judge, the City Fiscal, The City Engineer, the Station Commander and the Chief Traffic Officer, both of INP, and all in the City of Ormoc;




