RESOLUTION NO. 781

"RESOLVED, to adopt:

ORDINANCE NO. 24

AN ORDINANCE AMENDING SECTION 6 (PENALTY) OF ORDINANCE NO. 18

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 6 (Penalty) of Ordinance No. 18, otherwise known as the "Ormoc City Parking Ordinance of 1978", is hereby amended to read as follows:

"SECTION 6. Penalty. - Any violation of the provisions of this Ordinance shall subject the offender to a fine of One Hundred Fifty Pesos for the first offense; and for any subsequent offense, a fine of Two Hundred Pesos or an imprisonment of not less than five days, or both such fine and imprisonment at the discretion of the court."

SECTION 2. Effectivity. - This Ordinance shall take effect fifteen days after its approval.

Enacted, February 19, 1980.

"RESOLVED, FURTHER, to furnish a copy of this Ordinance each to the City Judge, the City Fiscal, the INP Station Commander, and all owners or drivers of motor vehicles in the City of Ormoc;
