RESOLUTION NO. 933

"WHEREAS, amidst today's complexities of modern life where it requires training, modern methods and innovative techniques to cope up with the social and economic needs of the under-privileged and less fortunate people in both urban and rural areas of this city, there is a need to have an integrated approach towards this development through the establishment of a technological, manpower training and research center which shall be charged of maintaining a continuous study, research, development and evaluation of various subjects or short seminars and courses by tapping governmental agencies and even private sectors that are involved in socio-economic development program geared to uplift the common and general welfare of the people;

"WHEREAS, the Center shall: (a) serve as a fountain-source of knowledge for manpower trainors, technologists and other specialists dealing with socio-economic development activities; (b) conduct seminars, workshops and short-term technological courses on any aspect of human endeavor in general, and manpower development in particular; (c) adopt a continuous education program to keep the people abreast with modern technology and update their skills and knowledge and acquaint them along the lines of modern social and economic trends; and (d) be the 'nerve center' of all phases of socio-economic training and all research activities in Ormoo City and shall, therefore, coordinate and monitor these activities and at the same time provide the link to all government and private sectors involved in the training, program and developmental activities;

"WHEREAS, with this integrated approach, individualized agency training program will be done away with but rather undertaken by the technological, manpower training and research center as the sole city government agency which shall be responsible for such training, research and development under a unified-effort scheme.

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded unanimously by all the rest of the Kagawad; be it

"RESOLVED, to adopt:

ORDINANCE NO. 27

AN ORDINANCE ESTABLISHING A TECHNOLOGICAL, MANPOWER TRAINING AND RESEARCH CENTER IN ORNOC CITY

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Center. - There shall be established in the City of Ormoc a center to be known as the "Ormoc City Technological, Manpower and Research Center" and which shall undertake the following objectives and functions:

- 1) Takes charge of conducting a continuous study, research, development and evaluation of various subjects or short seminars and courses by tapping governmental agencies and even private sectors that are involved in socio-economic development programs geared to uplift the common and general welfare of the people;
- 2) Serves as the fountain-source for manpower trainors, technologists and other specialists dealing with socio-economic development;
- 3) Conducts non-formal education training, seminars, workshops and short-term technological courses on any aspect of human endeavor in general, and manpower development in particular;
- 4) Adopts a continuing education program to keep the people abreast with modern technology and update their skills and know-ledge and acquaint them along the lines of modern social and economic trends; and
- 5) Serves as the "nerve center" of all phases of socio-economic training and all research activities, and shall, therefore,
 coordinate and monitor these activities and at the same time provide the link to all government and private sectors involved in
 the training, program and developmental activities.

SECTION 2. The Policy Making Body. - The policy making body of the Center shall be lodged in a Board of Trustees composed of the following: The City Mayor as Chairman, the Vice-Mayor as Vice-Chairman, and such members as the City Treasurer, the City Engineer, a Banggunian representative, the Manpower Development Officer of Ormoc, a representative from a reputable civic organization in Ormoc City to be appointed by the Chairman, a Ministry of Education and Culture representative on Non-Forman Education, the City Planning and Development Officer.

SECTION 3. Powers of the Board of Trustees. - The Board of Trustees shall, in addition to its duties as policy making body of the Center, also perform the following duties:

- a) Administer, control and supervise the activities provided for in Section 1 hereof;
- b) Elect from among themselves such other administrative officers of the Board as it may deem fit and necessary;
- c) Prescribe rules and regulations to carry out the purposes for which the Center is established;
 - d) Receive donations of all kinds for the Center;
- e) Procure and administer its funds and disbursements of the same; and
- f) Procure such facilities, tools and other things necessary to equip the Center so as to successfully accomplish its objectives and purposes.

SECTION 4. The Physical Plant. - There shall be erected a suitable building on a government lot where this Center shall be housed which shall have adequate spaces for seminar rooms, training bays, workshops, and andio-visual rooms. It shall also provide office spaces and rest rooms for seminar directors and trainors and such other facilities that are needed to carry out the objectives of the Center, and, that funds for the construction of the physical plant shall be derived from such sources as the Board of Trustees may deem proper and convenient.

SECTION 5. Funding. - The operation of the Center shall be funded from such sources as donations, grants in aid, and such other moneys as are obtained from various sources by the Center both from governmental and private agencies.

SECTION 6. <u>Automatic Integration</u>. - Any and all existing manpower trainors and technological programs shall be integrated into and/or vested in the herein created "Ormoc City Technological, Manpower Training and Research Center".

SECTION 7. Reside. - Any other ordinance or sections thereof inconsistent herewith are hereby repealed or modified accordingly.

SECTION 8. Effectivity. - This Ordinance shall take effect immediately upon its approval.

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable City Mayor, the Honorable Vice-Mayor, the City Treasurer, the City Engineer, the Manpower Development Officer, the Division Superintendent of City Schools, and the City Planning and Development Officer, all in the City of Ormoc;
