RESOLUTION NO. 994

"WHEREAS, with the acquisition of three (3) units of new service vehicles, that is, one each for the Offices of the Mayor, the Vice-Mayor, and Mga Kagawad, it becomes necessary to create three (3) new positions of Drivers, respectively; at P5,928.00 each per annum;

"WHEREAS, enrollment in the Ormoc City High School has soared anew that there is a need to employ at least four (4) new Secondary School Teachers; at P8,755.56 each per annum;

"WHEREAS, the growing volume of work in the City Health Department necessitates the creation of a new position of Supervising Public Health Nurse at P11,904.00 per annum;

"NOW, THEREFORE, on motion of Kagawad Besabella, seconded unanimously by all the other Mga Kagawad; be it

"RESOLVED, To adopt:

ORDINANCE NO. 28

AN ORDINANCE CREATING THE POSITIONS OF ONE DRIVER EACH IN THE OFFICES OF THE MAYOR, THE VICE-MAYOR, AND MGA KAGAWAD, FOUR SECONDARY SCHOOL TEACHERS IN THE ORMOC CITY HIGH SCHOOL AND ONE SUPERVISING PUBLIC HEALTH NURSE IN THE CITY HEALTH DEPARTMENT AND PROVIDING COMPENSATIONS THEREOF

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Creation of new positions. - The new positions are hereby created, providing compensations thereof, to wit:

3. OFFICE OF THE KAGAWAD (Sangguniang Panlungsod) One (1) Driver at P5,928.00 per annum	July 1, 1981
4. CITY HEALTH DEPARTMENT One (1) Supervising Public Health Nurse at P11,904.00 p.a.	July 1, 1981
5. ORMOC CITY HIGH SCHOOL Four (4) Secondary School Teachers @ P8,755.56 per annum	July 1, 1981



SECTION 2. Effectivity. - This Appropriation Ordinance shall take effect immediately upon its approval.




