RESOLUTION NO. 1009

SECTION 1. Placido C. Enedio Hall. - The session hall on the second floor of the Sangguniang Panlungsod Building of Ormoc City is hereby named "PLACIDO C. ENECIO HALL".

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
