RESOLUTION NO. 1010

"WHEREAS, the Highway District Engineer and Officer In-Charge of the City Engineering Department in his letter of July 1, 1981, has requested the creation of the position of Mechanical Engineer who will directly supervise the Motor Pool and Repair Bay Section of the said department in view of the ever increasing number of locally owned vehicular equipment and the need to fully maintain and rebuild existing equipment designed to their mechanical adaptations;

"WHEREAS, the creation of the position of Mechanical Engineer with a compensation at the rate of P14,532.00 per annum cannot be gainsaid considering that the Engineering Department needs a qualified personnel to inspect installations of mechanical equipment and/ or facilities of industrial building constructions such as the Biophil plant, the Ormoc Sugar Company mills, and other industrial buildings or plants and to review installation plans of mechanical facilities and other mechanical engineering works in processing building permits the fees of which will be large source of income for the city;

ORDINANCE NO. 30

AN ORDINANCE CREATING THE POSITION OF MECHANICAL ENGINEER IN THE OFFICE OF THE CITY ENGINEER WITH COMPENSATION AT THE RATE OF P14.532.00 PER ANNUM EFFECTIVE AUGUST 1, 1981, AND PROVIDING FUNDS THEREFOR

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Mechanical Engineer. - There is hereby created the position of Mechanical Engineer in the Office of the City Engineer with compensation at the rate of Fourteen Thousand Five Hundred Thirty-Two Pesos (P14,532.00) per annum effective August 1, 1981: PROVIDED, However that funds for this purpose shall be provided in subsequent supplemental and annual appropriation ordinances.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
