RESOLUTION NO. 1055

"WHEREAS, October 20 is a red-letter day for the Ormocanos as it marks a milestone in the historical development of this once-small town into a 'pioneer city of Leyte' born from the ravages of the last war but, nevertheless, nurtured by the ever-loving and toiling hands of dedicated citizens;

"WHEREAS, for a fitting observance of Ormoc City Charter Day every October 20 of the year it is but proper that the Honorable City Mayor, by virtue of Section 9(o) of Republic Act 179, otherwise known as the Charter of Ormoc City, proclaim this day as a public holiday for Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Tugonon, seconded jointly by Mga Kagawad Bandalan and Hermosilla; be it

"RESOLVED, to adopt:

ORDINANCE NO. 31

AN ORDINANCE AUTHORIZING THE HONORABLE CITY MAYOR TO PROCLAIM
EVERY OCTOBER 20 OF EACH YEAR AS A PUBLIC HOLIDAY IN ORMOC
CITY IN OBSERVANCE OF THE CITY CHARTER DAY

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Mayor to proclaim holiday. - In line with Section 9(o) of Republic Act 179, otherwise known as the Charter of Ormoc City, the City Mayor is hereby authorized to proclaim every October 20 of each year as a public holiday in Ormoc City in observance of City Charter Day.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, October 13, 1981.
