ORDINANCE NO. 32

AN ORDINANCE PRESCRIBING RULES AND REGULATIONS GOVERNING THE USE OF THE PUBLIC STACE, HALLS OR BUILDINGS AND OTHER GOVERNMENT STRUCTURES OF ORMOC CITY

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Title. - This Ordinance shall be known as the "Ormoc City Government Structures Utility Ordinance".

SECTION 2. Definition of terms. - For purposes of this Ordinance, the following terms are hereunder defined:

- a) Public stage the roof-covered city stage erected between the seawall and Imelda Boulevard away behind the city hall.
- b) Sanggunian hall the session hall (Hon. Placido C. Enecio Hall on the second floor of the Sanggunian building.
 - c) City hall roof garden the third floor of the city hall.
- d) Other government structures include the shore protection development areas and any such future halls or buildings as the ABC Hall, the sports and recreation center, the manpower training center, and any other buildings constructed by the City Government of Ormoc.
- e) Entity proprietorship, partnership, corporation, association, organization or the like.
 - f) Day any or all duration between sunrise and sunset.
 - g) Night any or all duration between sunset and sunrise.

SECTION 3. Mayor's permission and utility fees. - The use of the public stage, the Sanggunian hall, the city hall roof garden, or any other government structures by any person or entity for the purpose of promoting commercial products, holding benefit shows, exhibitions or the like to raise funds for the sole benefit of such person or entity shall be allowed after the necessary permission shall have been secured from the Office of the City Mayor and the fees for such use paid, which payment shall inure to the City

for the upkeep or maintenance, light consumption, and janitorial and other services.

SECTION 4. Time and manner of payment. - Immediately upon having secured the necessary permission from the City Mayor for the use of the public stage, Sanggunian hall, city hall roof garden, or any other government structures, there shall be paid to the City Treasurer by the permittee a nominal fee, to wit:

SECTION 5. Exemption. - The use of the public stage by any person or entity for purposes of a cultural show which is intended for public service is hereby exempted from the imposition of the nominal fee prescribed in the preceding section: PROVIDED, HOWEVER, That the necessary Mayor's perssion shall have been first secured.

Any permittee using the public stage, Sanggunian hall, city hall roof garden, or any other government structures shall see to it that all walls, posts, ceilings and other fixtures of such structure, including its furniture, shall be free from nails, thumb tacks, glues, pastes and other materials adherent to decorations that will damage or stain such fixtures and furnishings, including the floorings. The permittee shall be responsible for any damage or destruction whatsoever made on any furniture or fixture of the government structure used and, further, said permittee shall be responsible for the removal of all decorations or additional fixtures immediately after the affair or not later than eight o'clock of the following morning.

SECTION 7. Penalty for violation. - Any violation of the provisions of this Ordinance shall be punishable by a fine of not exceeding two hundred pesos or an imprisonment of not exceeding ten days, or both such fine and imprisonment at the discretion of the court.

SECTION 8. Separability. - If any section or part of this Ordinance shall be declared unconstitutional or ultra-vires, the said declaration shall invalidate the whole hereof.

SECTION 9. Repeal. - Any ordinance or part thereof inconsistent herewith is hereby repealed or modified accordingly.

SECTION 10. Effectivity. - This Ordinance shall take effect immediately upon its approval.
