RESOLUTION NO. 1127 ✓

"WHEREAS, the barangay officials and the great majority of the residents of Barangay Tuog have, through the Honorable City Mayor, requested this august Body in a joint petition dated January 6, 1982, that the barangay be renamed BARANGAY DOÑA FELIZA Z. MEJIA in honor of a grand lady of Ormoc whose altruism and Christian spirit have been made manifest in her desire to bring about progress and prosperity in this community which formed the biggest part of her subdivision where she constructed a chapel for the inhabitants to gather together and pray jointly every week and, in addition, donated one hectare of her lot to be made available for the school site of Barangay Tuog;

"WHEREAS, this august Body finds the joint petition of the barangay officials and inhabitants of Tuog most worthy of consideration as we appreciate and admire Mrs. Feliza Zamora vda. de Mejia for the generosity with which she parted her time, effort, money and a lot of property for the general well-being of her Christian neighbors such that we find it fitting and proper that Barangay Tuog be renamed after her;

SECTION 1. Barangay Doña Feliza Z. Mejia. - Barangay Tuog in the City of Ormoc is hereby renamed "Barangay Doña Feliza Z. Mejia".


SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.



"CARRIED UNANIMOUSLY."




