RESOLUTION NO. 1141

"WHEREAS, the Senior Public Health Nurse, for and in the absence of the Acting City Health Officer, in her communication of February 22, 1982, had requested the creation of the position of Senior Clinic Physician in the City Health Office in order that the ten barangay health centers attending to five to eight barangays as their catchment areas could be regularly served inasmuch as at present they are in dire need of medical practitioners to look after the health of the people and the sanitation of the communities;

"WHEREAS, the Public Health Nurse reported that the salary savings of the unfilled vacant positions of City Health Officer and Medical Services Supervisor, among others, in her office may be availed of to provide the salary of Senior Clinic Physician which, upon consultation with the City Personnel Officer, calls for a rate of P16,044.00 per annum and, considering that there are only nine months left from April to December, this year, the actual compensation will be only in the amount of P12,033.00 plus P2,480.63 for life, retirement, Medicare, and state workmen's insurances and PagIBIG premiums and cost of living allowance for the same period of time (9 months) all in all totalling P14,513.63;

"WHEREAS, this august Body finds the request of the Public Health Nurse most worthy of our consideration taking into account the lack of physicians in the City Health Office and the urgency of their services specially in the rural areas;

"NOW, THEREFORE, on motion of Kagawad Samson, seconded by Kagawad Besabella; be it

"RESOLVED, to adopt:

ORDINANCE NO. 34

AN ORDINANCE CREATING THE POSITION OF SENIOR CLINIC PHYSICIAN
IN THE CITY HEALTH OFFICE WITH COMPENSATION AT THE RATE
OF SIXTEEN THOUSAND FORTY-FOUR PESOS PER ANNUM

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That

SECTION 1. Senior Clinic Physician. - There is hereby created in the City Health Office the position of Senior Clinic Physician with a compensation at the rate of ~~P~~^{Sixteen} ~~044.00~~ ^{Thousand Forty-Four Pesos (P16,} ~~044.00)~~ per annum: PROVIDED, However, that funds for this purpose shall be provided in subsequent appropriation ordinances.


SECTION 2. Effectivity. - This Ordinance shall take effect on April 1, 1982.



"CARRIED UNANIMOUSLY."




