RESOLUTION NO. 1166

"RESOLVED, to adopt:

ORDINANCE NO. 36

AN ORDINANCE CREATING THE POSITION OF ASSISTANT CITY ENGINEER WITH COMPENSATION AT THE RATE OF THIRTY-THREE THOUSAND EIGHT HUNDRED FORTY PESOS PER ANNUM

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Assistant City Engineer; his compensation. - The position of Assistant City Engineer is hereby created in the Office of the City Engineer with compensation at the rate of Thirty-Three Thousand Eight Hundred Forty Pesos (P33,840.00) per annum: PROVIDED, HOWEVER, That funds for this purpose shall be provided in subsequent appropriation ordinances.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
