AN ORDINANCE TO AMEND ORDINANCE NO. 34 RELATIVE TO THE CREATION OF THE POSITION OF SENIOR CLINIC PHYSICIAN IN THE CITY HEALTH DEPARTMENT.

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Ordinance No. 34 creating the position of Senior Clinic Physician in the City Health Department is hereby amended by changing the title of said position to "Medical Officer I" as approved by the Joint Commission on Local Government Personnel Administration.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
