RESOLUTION NO. 1237

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besa-
bella, seconded by Kagawad Mendola;

"RESOLVED, to adopt:

ORDINANCE NO. 38

AN ORDINANCE REQUIRING COMPLIANCE WITH PD 1752, OTHERWISE
KNOWN AS THE "HOME DEVELOPMENT MUTUAL FUND LAW OF
1980", BEFORE ISSUANCE OF BUSINESS OR MAYOR'S
PERMITS AND/OR LICENSES, INCLUDING RENEWALS

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Basic rule. - It is mandated by Presidential Decree
No. 1752 dated December 14, 1980, that all employees covered by the
Government Service Insurance System (GSIS) and the Social Security
System (SSS) and their respective employers shall be mandatorily
covered by the Home Development Mutual Fund, otherwise known as the
Pag-I.B.I.G. Fund. (Pag-I.B.I.G. is the acronym for Pag-tutulungan
sa kinabukasan, Ikaw, Bangko, Industriya, Gobyerno.)

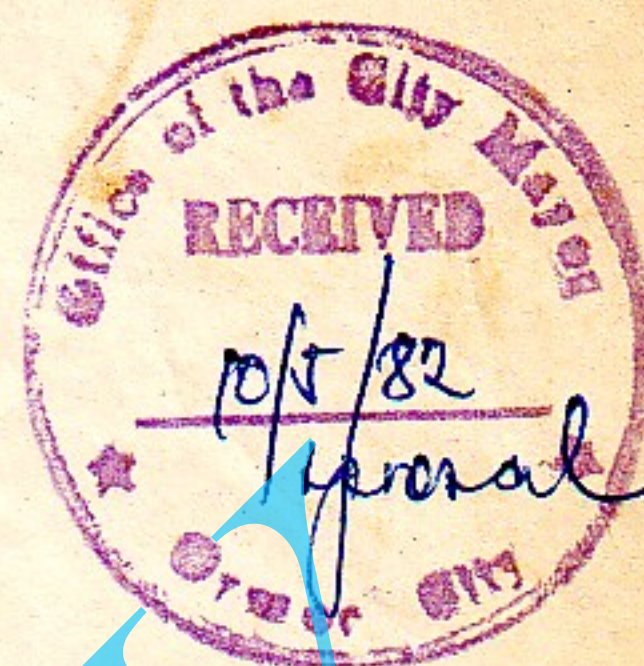
SECTION 2. Title. - This Ordinance shall be known as the "Ormoc
City Pag-I.B.I.G. Fund Coverage Ordinance".

SECTION 3. Objective. - The Pag-I.B.I.G. Fund was created to
motivate the employed and other working groups so they may save for
their future through membership in an integrated, nation-wide sav-
ings system with contributory support of employers, in the spirit
of social justice and the pursuit of national development.

SECTION 4. Condition of issuance of business or Mayor's per-
mits and/or licenses. - The Pag-I.B.I.G. Fund, being created pure-
ly for the interest and singular benefit of the working group and
to carry out effectively its noble objectives, it is hereby made
as a condition for the issuance of business or Mayor's permits and/
or licenses, including renewals, compliance by employers with Pre-
sidential Decree No. 1752.

SECTION 5. Exemption. - Exempted from the imposition of the
preceding section are:

1. New businesses applying for the first time who have no
SSS-covered employees yet;



2. Self-employed individuals whose workers are limited to themselves and the immediate members of their families;

3. Employers without any SSS-covered employees. Non-SSS-covered employees included:

- (a) Domestics;
- (b) Agricultural workers who are not paid regularly for an uninterrupted period of at least six months;
- (c) Student-assistants in schools, colleges and universities where they are enrolled;
- (d) Student-nurses and medical interns;
- (e) Casual employees; and
- (f) Those specifically excluded or exempted by the SSS.

SECTION 6. Certificate of registration. - The proof of compliance with P.D. 1752 shall be evidenced by a Certificate of Registration with the Pag-I.B.I.G. Fund issued by the Home Development Mutual Fund or a copy of the latest receipt of remittance to the Fund or, if the employer has been granted a waiver or suspension (exemption) of Fund Coverage, copy of certificate of waiver or suspension issued by the Home Development Mutual Fund.

SECTION 7. Proof of compliance with PD 1752. - The application for issuance of business or Mayor's permits and/or licenses, including renewals, shall not be accepted or processed and permits and/or licenses, including renewals thereof, shall not be issued unless the employer-applicant presents proof of compliance with Presidential Decree No. 1752.

SECTION 8. Effectivity. - This Ordinance shall take effect immediately upon its approval.
