"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Besa-  
bella, seconded by Kagawad Torrevillas;

"RESOLVED, to adopt:

ORDINANCE NO. 40

AN ORDINANCE TO AMEND SECTION 3 OF ORDINANCE NO. 32,  
OTHERWISE KNOWN AS THE "ORMOC CITY GOVERNMENT  
STRUCTURES UTILITY ORDINANCE"

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment. - Section 3 of Ordinance No. 32, otherwise  
known as the "Ormoc City Government Structures Utility Ordinance", is  
hereby amended to read as follows:

"SECTION 3. Mayor's permission and utility fees. - The use  
of the public stage, the Sanggunian hall, the city hall roof  
garden, or any other government structures by any person or en-  
tity for the purpose of promoting commercial products, holding  
benefit shows, exhibitions or the like to raise funds for the  
sole benefit of such person or entity shall be allowed after  
the necessary permission shall have been secured from the Of-  
fice of the City Mayor and the fees for such use paid, which  
payment shall inure to the City for the upkeep or maintenance,  
light consumption, and janitorial services: PROVIDED, HOWEVER,  
That with respect to the Sanggunian (Hon. Placido C. Enecio)  
hall, the same shall not be used for any purpose or purposes  
except conventions, seminars, workshops and the like as may  
be sponsored by any government entity or corporation."

SECTION 2. Effectivity. - This Ordinance shall take effect imme-  
diately upon its approval.
