ORDINANCE NO. 43 -

AN ORDINANCE TO FURTHER UPGRADE THE POSITION OF ASSISTANT CIVIL  
ENGINEER TO CIVIL ENGINEER (ITEM 393) IN THE PROGRAMMING AND  
PLANNING STAFF OF THE CITY ENGINEER'S OFFICE WITH COMPENSA-  
TION OF P16860 (from P15264) PER ANNUM EFFECTIVE AUGUST 1,  
1984.

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Assistant Civil Engineer Upgraded. - The position of  
Assistant Civil Engineer in Item No. 393 under the Programming and  
Planning Staff of the City Engineer's Office with compensation at the  
rate of P15624 per annum, per Ordinance No. 42, is hereby upgraded,  
further, to the position of Civil Engineer with compensation at the  
rate of SIXTEEN THOUSAND EIGHT HUNDRED SIXTY PESOS (P16,860.00) PER  
ANNUM effective as of August 1, 1984: PROVIDED, However, That fund  
for this purpose shall be provided in subsequent Infrastructure Fund  
budgets.

SECTION 2. Effectivity. - This Ordinance shall take effect im-  
mediately upon its approval.
