ORDINANCE NO. 44 -

AN ORDINANCE TO AMEND SECTION 18 (ON WATER METER PAYMENT)
OF MUNICIPAL BOARD ORDINANCE NO. 6, SERIES OF 1948

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Amendment to Municipal Board Ordinance No. 6, series of 1948. - Section 18 of Municipal Board Ordinance No. 6, series of 1948, appertaining to payment for water meters, is hereby amended by inserting a new paragraph between sub-paragraph "d" and the title "TESTING, SEALING AND REPAIRING OF WATER METERS" which shall read as follows:

"PROVIDED, HOWEVER, That any consumer shall have the option to either adopt the foregoing mode of payment for the water meter or pay it by installments for a period of not exceeding sixty (60) months: PROVIDED, FURTHER, that prior to full payment therefor the City shall remain the owner of the water meter and that any damage or loss of the same shall be the sole responsibility of the consumer."

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
