ORDINANCE NO. 45

AN ORDINANCE TO TRANSFER ITEM NO. 307, CIVIL REGISTRY CLERK AT P9288 PER ANNUM, FROM THE CITY HEALTH OFFICE TO THE CITY PLANNING AND DEVELOPMENT STAFF, PURSUANT TO THE PROVISIONS OF THE LOCAL GOVERNMENT CODE, THEREUNDER TO BE KNOWN AS ITEM NO. 113-A.

BE IT ORDAINED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Civil Registry Clerk transfer. - Item No. 307, Civil Registry Clerk with compensation at the rate of P9288 per annum, is hereby transferred from the City Health Office to the City Planning and Development Staff, pursuant to the provisions of the Local Government Code, and thereunder to be known as Item No. 113-A.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
