"RESOLVED, to adopt:

ORDINANCE NO. 47

AN ORDINANCE CREATING THE POSITION OF SENIOR EXECUTIVE ASSISTANT II, GRADE LEVEL 15, IN THE OFFICE OF THE CITY MAYOR.

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. The Senior Executive Assistant II, Grade level 15. - The position of Senior Executive Assistant II, Grade level 15 is hereby created in the Office of the City Mayor, which position absorbs the functions of the City Administrator being phased out by the Joint Commission on Local Government Personnel Administration in accordance with the standard staffing pattern for component cities.

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.
