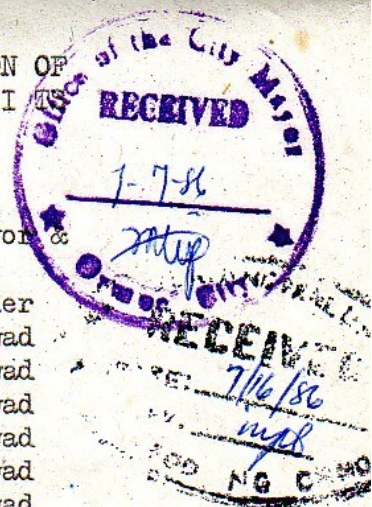

"WHEREAS, for the smooth operation of the local government offices in the City of Ormoc, it has become imperative to create various positions of different local government offices with their respective corresponding compensations, as follows: eighteen (18) Utility Workers, G-1 @ P5,007.24 each per annum, City Mayor's Office; two (2) Utility Workers, G-1 @ P5,007.24 each per annum, Sangguniang Panlungsod Secretariat; one (1) Budget Examiner, G-9 @ P16,860.00 per annum and one (1) Clerk, G-2 @ P7,992.00 per annum, City Budget Office; one (1) Janitor, G-1 @ P6,552.00 per annum, City Fiscal's Office; five (5) Public Health Midwives, G-6 @ P10,776.00 each per annum, City Health Office; one (1) Social Worker, G-7 @ P11,328.00 per annum, MSSD Office; one (1) Sec. School Teacher, R-56 @ P13,152.00 per annum, Ormoc City High School; and two (2) Bill Collector, G-2 @ P7,992.00 each per annum, Ormoc Waterworks Office;

"RESOLVED, to adopt:

ORDINANCE NO. 1

AN ORDINANCE CREATING VARIOUS POSITIONS OF DIFFERENT LOCAL GOVERNMENT OFFICES IN ORMOC CITY WITH THEIR RESPECTIVE CORRESPONDING COMPENSATIONS, AS FOLLOWS: EIGHTEEN (18) UTILITY WORKERS, G-1 @ P5,007.24 EACH PER ANNUM; CITY MAYOR'S OFFICE; TWO (2) UTILITY WORKERS, G-1 @ P5,007.24 EACH PER ANNUM, SANGGUNIANG PANLUNGSOD SECRETARIAT; ONE (1) BUDGET EXAMINER, G-9 @ P16,860.00 PER ANNUM AND ONE (1) CLERK, G-2 @ P7,992.00 PER ANNUM, CITY BUDGET OFFICE; ONE (1) JANITOR, G-1 @ P6,552.00 PER ANNUM, CITY FISCAL'S OFFICE; FIVE (5) PUBLIC HEALTH MIDWIVES, G-6 @ P10,776.00 EACH PER ANNUM, CITY HEALTH OFFICE; ONE (1) SOCIAL WORKER, G-7 @ P11,328.00 PER ANNUM, MSSD OFFICE; ONE (1) SEC. SCHOOL TEACHER, R-56 @ P13,152.00 PER ANNUM, ORMOC CITY HIGH SCHOOL; AND TWO (2) BILL COLLECTORS, G-2 @ P7,992.00 EACH PER ANNUM, ORMOC WATERWORKS OFFICE, EFFECTIVE JANUARY 1, 1987.

BE IT ENACTED, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Creation of various positions of different local government offices in the City of Ormoc with their respective corresponding compensation. - The various positions of different local government offices in Ormoc City with their respective corresponding compensations are hereby created, as follows:

| 9. Ormoc Waterworks Office | 2-Bill Collector | G-2 | 7,992.00 each |

PROVIDED, HOWEVER, that funds for this purpose shall be provided in subsequent general appropriation ordinance;




