WHEREAS, in the community of Ormoc, now Ormoc City, Dr. 'Otik' as he has been fondly called by residents of this city, has ated a considerable area in Barangay Can-adieng where he resided, to the Community School of Barangay Can-adieng;

ever since Dr. Fiel was assigned in Ormoc municipality, then Ormoc City, he has been known by all to go out of his way to attend to citizens who needed his service as City Health Officer;

"RESOLVED, to adopt:

ORDINANCE NO. 3

AN ORDINANCE RENAMING CONCEPCION STREET OF BARANGAY CAN-ADIENG. ORNOC CITY, "DR. EUTIQUIANO EAMIGUEL FIEL".

BE IT ENACTED, by the Sangguniang Panlungsod ng Grmoc, That:

SECTION 1. Concepcion Street of Barangay Can-adieng, Ormoc City is hereby renamed "Dr. Eutiquiano Eamiguel Fiel Street".

SECTION 2. This Ordinance shall take effect immediately upon its approval.

A BIOGRAPHY OF:

DR. BYTQUEWO BEWUTTEN MAN

Dr. Eutiquiano Eamiguel fiel was born on December 8, 1901 in Barrio Can-adieng, Ormoc, Leyte. He was the only child of his parents Antero Aparis Fiel and Isabel Eamiguel. He finished his elementary education in Ormoc, Leyte, and High School at the Cebu Provincial High School, Cebu City, where he graduated with high honors. He took his Pre-Med. Course at the Cebu Junior College of the University of the Philippines, and later went to Manila where he finished his Doctor of Medicine Course at the University of Sto. Thomas in 1928. He took the Medical Board Examination in 1929 and passed said examination as board topnotcher having placed 4th among the list of successful examinees. In the same year he passed the examination for 1st Grade Civil Service eligibility, which was then a requirement for government service applicants during that period.

Immediately after becoming a licensed Doctor of Medicine and a 1st grade C.S., eligible, he was appointed as the Sanitary Division President for the area covering the towns of Inopacan, Hindang, Hilongos, Bato and Matalom all in the province of Leyte with Division Office at Bato, Leyte from 1929 to 1931.

Because of diligence and hard work and love for the service of humanity he maintained his position as Sanitary Division President. During the later period of 1931 he was transferred and appointed as President of the Sanitary Division comprising the towns of Palompon, Villaba and San Isidro all in Leyte where there was serious epidemic of cholera, dysentery and yaws with station at Palompon, Leyte, from 1931 to 1937.

Due to request of his fellow Ormocaros and thru the intervention of the then Congressman Dominador M. Tan, he was transferred to his hometown of Ormoc, Leyte as Sanitary Division President for the area covering Albuera, Ormoc and Merida all in Leyte with main office at Ormoc, Leyte where he served from 1938 to 1947.

When the municipality of Ormoc was converted into a city in 1947, he was appointed as the first City Health Officer of the newly created City of Ormoc. It was a position well worth of him. However due to intervention and manipulation of political parties and the change of administration that followed in 1953 a new City Health Officer was appointed in Ormoc City and Dr. Fiel's position was reduced to Assistant CHO despite his excellent records of performance and qualifications to back his retention. However, after eight (8) long years of dedicated service he was reappointed as City Health Officer on the later period of 1962 and he served as such till his retirement from government service in December 1966.

Dr. Eutiquio Fiel was a prominent figure during the Second World War (thru the intercession of Hon. Potenciano A. Larrazabal who was the Mayor of Ormoc during the Liberation period) he became Chief of a hospital established by the 7th Division of the American Liberation Forces at barrio Benolho, Albuera, Leyte, and later he was appointed Chief of the Hospital in Ormoc which was established and maintained by the American PCAU to serve the medical and surgical needs of the civilian casualties of the Second World War.

During the Japanese occupation he was forced by the Japanese Armed forces to continue his work as the civil government doctor in Ormoc. He unwillingly obliged himself to work with the Japanese for the reason of serving the Filipinos in the poblacion, but he risked his life and sacrificed the safety of his family by secretly communicating and

giving assistance to the Filipino guerillas and civilians in the mountains in the form of medicines and medical assistance.

A philantrophist, he donated several parcels of land which were converted to barrio and school sites for barrio Can-adieng, Ormoc, Leyte.

Dr. Eutiquiano Fiel married the former Consuelo Penalosa Tan who also retired from Government Service as Head Teacher of Can-adieng Community School in 1967. Their union begot 7 children, and through their sacrifices in the proper nurture and upbringing, he gave his children the education which made them prominent and highly esteemed in their respective fields.

one is presently a member of the 3rd Sangguniang Panlungsod of Ormoc, Antero Fiel who is married to Veronica Sanchez; Remedios Fiel a pharmacist, is married to Engr. Carmelo Marguez; Heliodoro Fiel, former Vice-Mayor of Ormoc City, presently RTC Judge, married to Pura Catingub; Esperanza Fiel, presently the City Judge of Cebu City, is married to Atty. Pablo P. Garcia, former Vice-Gov. of Cebu and now Congressman of the 3rd District of Cebu; Manuel Fiel formerly Kagawad, 2nd Sangguniang Panlungsod of Ormoc and presently the president of the Western Leyte College is married to Brenda Adalfo; Venerando, Fiel, a Doctor of Medicine who is now in the USA and married to Engr. Evasio Cagande and Prudencio Fiel, Chemical Engr. and Master of Business Administration and presently supervisor for NISSAN Corp. covering 12 States in U.S.A. He is married to Alex Orat.

Dr. Eutiquiano E. Fiel, fondly called by his friends "Otik" was remembered for his selfless devotion to his duty, his ever ready cooperation in all affairs and his unswerving faith in his God. He was a Grand Knight of the Knights of Columbus and was Knight of the Year when ex-Mayor Jose V. Aviles was Grand Knight. Dr. Fiel was an accomplished musician. He was a versatile violinist. Dr. Fiel died on Sept. 4, 1980 at the age of 79.
