ORRINANCE NO. 5

ORDINANCE TO OUTLAW HOT WEAT OR "MEJORAS" FROM SIDEWALKS MOST RSPECIALLY IN THE ORMOC CITY PUBLIC MARKET, PROVIDING PENALTY FOR VICLATION THEREOF, AND FOR OTHER PURPOSES.

BY IT ORDAINAR, by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1 Definition of term. - For purposes of this Ordinance the following term is hereby defined:

ot Meat or "Mejoras". - means all parts of the meat that has not been inspected by the Meat Inspector which may include cats, dogs, rats and other animals.

SECTION 2. It shall be unlawful for any person or group of persons to sell, offer for sale, of hot meat or "mejoras" from sidewalks most especially in the Ormoc City Public Market.

SECTION 3. Penalty. - Any violation of the provisions of this Ordinance shall subject the offender to the following penalties:

a) First infraction a fine of \$25.00;

b) Second infraction a fine of \$50.00;

c) Third infraction an imprisonment of not more than fifteen (15) days or a fine of 775.00 or both such fine and imprisonment at the discretion of the court.

SECTION 4. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, August 6, 1986.
