WHEREAS; the residents of our barangay find it fitting and proper to express their gratitude and thanks for this forthcoming project which will hinge on the acquiescence of the heirs of the late Dr. Serafica;

NOW THEREFORE; on motion of Kagawad Balatong, unanimously seconded by all the members of the Barangay Council in session; be it

RESOLVED, AS IT IS HEREBY RESOLVED; to pass a resolution earnestly requesting the Honorable Members of the 3rd Sangguniang Panlungsod ng Ormoc to confirm the desire of the residents of Barangay Bayog and pass an Ordinance renaming Barangay Bayog to Barangay Dr. Hermenegildo C. Serafica; pursuant to Section 82 and Sec. 84 of Batas Pambansa 337, otherwise known as the Local Government Code;

SECTION 1. Renaming of Barangay Bayog. - Barangay Bayog, in the city of Ormoc, is hereby renamed "Dr. Hermenegildo Costes Serafica."
