RESOLUTION NO. 218

"WHEREAS, Section 169 (4) of the Local Government Code otherwise known as Batas Pambansa Blg. 337 provides that the 'Minister of Local Government shall prescribe, in consultation with cities, minimum standards guidelines with respect to their organizational structures, staffing pattern and other relevant operational aspects according to needs';

"WHEREAS, MLG Circular 83-29 dated December 6, 1983 mandates to exercise the power to reorganize the city governments to promote efficiency and economy in city administration, as provided for in Section 177 (cc) of the Local Government Code";

"WHEREAS, on the 3rd Indorsement dated January 19, 1987 Honorable Resurreccion S. Salvatierra, Assistant Regional Director has recommended for the reorganization of the city government of Ormoc as mandated in the Local Government Code and of Circular No. 83-29;

"WHEREAS, if this reorganization will be pushed through this would ease out undesirable employees in the local government of Ormoc City thereby making for an uninterrupted flow of efficient public service;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, unanimously seconded; be it

"RESOLVED, to adopt:

ORDINANCE NO. 6

AN ORDINANCE ADOPTING AND IMPLEMENTING THE ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN IN THE LOCAL GOVERNMENT OF ORMOC AS MANDATED IN SECTION 169 (4) OF THE LOCAL GOVERNMENT CODE OTHERWISE KNOWN AS BATAS PAMBANSA BLG. 337 AND PURSUANT TO MLG CIRCULAR NO. 83-29 DATED DECEMBER 6, 1983 AND AS PER RECOMMENDATION OF HONORABLE RESURRECCION S. SALVATIERRA, DLG ASSISTANT REGIONAL DIRECTOR, REGIONAL OFFICE NO. VIII, TACLOBAN CITY.

(RES. NO. 218, ORD. NO. 6)

BE IT ENACTED: by the Sangguniang Panlungsod ng Ormoc, That:

SECTION 1. Adopting and Implementing the Organizational Structure and Staffing Pattern - The Organizational Structure and Staffing Pattern in the Local Government of Ormoc is hereby adopted and implemented, pursuant to Section 169 (4) of the Local Government Code, otherwise known as Batas Pambansa Blg. 337 and MLG Circular No. 83-29 dated December 6, 1983 and as per recommendation of Honorable Resurreccion S. Salvatierra, Assistant DLG Regional Director, Tacloban City;

SECTION 2. Effectivity. - This Ordinance shall take effect immediately upon its approval.

ENACTED, May 20, 1987.

RESOLVED, FURTHER, to furnish a copy of this resolution-ordinance each to the Joint Commission on Local Government Personnel Administration, Metro Manila; Hon. Resurreccion S. Salvatierra, Assistant Regional Director, Department of Local Government and the Regional Director; Civil Service Commission; both in Tacloban City; and the Personnel Officer V, Ormoc City;




